#### FOREWORD

This *Scoping Paper on Online Identity Theft* was discussed by the Committee on Consumer Policy ("CCP") at its 73<sup>rd</sup> and 74<sup>th</sup> Sessions in 2007. It was prepared by Brigitte Acoca, of the OECD Secretariat, based on independent research and member countries' input. It served as a basis for the development, in 2007 and 2008, of CCP's policy principles on online identity theft.

The paper was declassified by the Committee on Consumer Policy on 9 January 2008, under the written procedure. It is published under the responsibility of the Secretary-General of the OECD.

#### SUMMARY

#### Background

At its 72<sup>nd</sup> Session in October 2006, the Committee on Consumer Policy ("CCP") agreed to carry out an analysis of on line identity theft, in support of the work carried out by the OECD's Committee for Information, Computer, and Communications Policy ("ICCP") on the broad trends and policies that will shape the future of the Internet. The analysis served as the basis for the development, in 2007 and 2008, of CCP's policy principles to combat such theft; these principles would be considered at the Ministerial-level meeting organised by the ICCP on 17-18 June 2008 in Seoul, Korea.

#### Structure of the analysis

The analysis is presented in five sections:

- Section I of the analysis examines the different legal approaches adopted by OECD member countries to address ID theft and examines the implications of creating a separate criminal offense for ID theft.
- Section II describes the different methods that ID thieves use to obtain victims' personal information, including social engineering techniques and technical subterfuge involving the installation of malicious software ("malware").
- Section III describes the different ways in which ID thieves misuse victims' personal information.
- Section IV provides a profile of ID theft victims. It draws on the available statistical data reflecting victims' complaints and losses trends. It questions whether ID theft is more prevalent off than on-line.
- Section V sets out OECD member country and international enforcement efforts aimed at stemming on line ID theft.

#### **Defining identity theft ("ID theft")**

ID theft is defined differently in OECD member countries: some view it as a specific crime, while others regard it as a preparatory step in the commission of other wrongs or crimes. For the purposes of this paper, the following definition is used:

ID theft occurs when a party acquires, transfers, possesses, or uses personal information of a natural or legal person in an unauthorised manner, with the intent to commit, or in connection with, fraud or other crimes.

This definition applies regardless of the medium in which ID theft is perpetrated. Although this definition encompasses both individuals and legal entities, focus in the present paper is limited to identity theft affecting consumers.

#### ID thieves' on line toolkit

Generally, ID thieves employ a variety of different methods to obtain victims' personal information. Some on line tools include the activation of malware, a program installed on a computer system for the purpose of causing harm to that system or to others; "phishing," whereby thieves lure Internet users by sending deceptive e-mails or by using fake websites to trick users into disclosing personal information; and the use of these phishing messages, which are widely distributed by spam, often to install malware on the computers of recipients.

Phishing techniques are becoming more sophisticated and more difficult to detect. Some of the principal forms are:

- "Pharming:" this type of message uses the same kind of false identifiers as in a classic phishing attack and at the same time redirects users from an authentic website to a fraudulent site that replicates the original in appearance.
- "SMiShing:" cell phone users receive text messages ("SMS") where a company confirms to them that they have signed up for one of its services, indicating that they will be charged a certain amount per day unless they cancel their order at the company's website.
- "Spear-phishing:" the sender impersonates a company's employee/employer to steal their colleagues' passwords/usernames to ultimately access the company's computer system.

#### The different forms of ID theft

ID thieves misuse victims' personal information in furtherance of a variety of different unlawful schemes. Typically, these schemes involve misuse of existing accounts, opening new accounts, fraudulently obtaining government benefits, services, or documents, health care fraud, and unauthorized brokering of personal data.

#### The scale of online ID theft is difficult to measure

Statistics are collected differently by countries, complicating cross-border comparisons. Moreover, statistics collected by public and private entities vary greatly: some sources conclude that the scale of ID theft has gone down in the past years, resulting in growing consumer confidence. In contrast, other sources advance figures reflecting an increase in ID theft.

#### **Domestic enforcement strategies**

In most OECD member countries, public authorities and the private sector have developed a range of consumer and user education tools to combat ID theft. In some countries, information is shared between various public and private bodies to investigate and prosecute ID theft. Resources to police are, however, limited in many countries.

Companies in some countries have understood the need to deploy human resources and security strategies to prevent data leakage. However, there is recognition that more needs to be done to ensure that they adequately prevent those data security breaches. A few countries have taken steps in this direction, imposing an obligation on data collectors such as companies and Internet service providers ("ISPs") to disclose such breaches to their affected customers and the public. Others are still considering whether such information disclosure should be adopted through laws only. In some European Union Member States,

ISPs are requesting the right to act on behalf of their customers if their personal information is misused and results in direct and indirect losses.

#### **International enforcement**

#### Intergovernmental initiatives

Various international organisations and groups are involved in fighting cyber fraud. The OECD, for example, has developed policy responses in the areas of fraud against consumers, spam, security and privacy. Instruments include the 1999 E-commerce Guidelines, the 2003 Cross-border Fraud Guidelines, the 2002 Security Guidelines of Information Systems and Network, the 1980 Guidelines on the Protection of Privacy and Transborder Flows of Personal Data and the 2006 Anti-Spam Toolkit.

The International Telecommunication Union and the Asia-Europe Meeting are other platforms involved in the fight against on line threats. Interpol, the police organisation whose mission is to combat international crime, frequently serves as the basis of co-operation between national police forces in conducting multinational investigations of on line crime.

In addition, there have been a number of bilateral, multilateral and regional schemes whereby law enforcement, police and government bodies have joined forces to prevent and prosecute on line ID theft.

#### Public-private sector international enforcement initiatives

The private sector joins public authorities' efforts to tackle cyber attacks under various initiatives. Some are data-sharing forums gathering statistics on phishing, malware and other on line threats. Some are enforcement oriented, assisting governments in investigations, implementing adapted technological tools, and proposing recommendations for the development of tailored legislative and best practices aimed at stemming ID theft in the online environment.

#### Issues

This analysis suggests that stakeholders should consider addressing a number of issues to improve their efforts to combat online ID theft:

- **Definition** -- The lack of a common definition may complicate efforts to combat ID theft in a comprehensive fashion, across borders.
- *Legal status* -- ID theft/fraud is not an offence *per se* under most OECD member country laws. It is a crime in a few others. Whether ID theft should be treated as a stand-alone offence, and criminalised, needs to be considered.
- **Co-operation with private sector** -- The private sector should actively participate in the battle. member countries could consider enacting more restrictive laws increasing penalties imposed on ID thieves; engage in outreach to the private sector and encourage entities to *i*) launch awareness campaigns, *ii*) develop industry best practices and *iii*) develop and implement other technological solutions to reduce the incidence of ID theft.
- *Standards* -- Member countries should examine establishing national standards for private sector data protection requirements and impose a duty to disclose data security breaches on companies and other organisations storing data about their customers.

- *Statistics* -- ID theft (whether off or on-line) has failed to attract the attention of statisticians. Most data are from the United States; statistics for Europe do not exist, except for the United Kingdom. When data are available, they often do not cover ID theft as an independent wrong. The United States is notably one of the few countries with data available that analyse ID theft as a separate offense. The production of more tailored and accurate statistical data, covering all OECD member countries could help determine the impact of ID theft in the digital marketplace.
- *Victim assistance* -- member countries could consider developing victim assistance programs to help victims of ID theft recover and minimise their injury.
- *Remedies* -- Member countries could consider whether to enact legislation to provide more effective legal remedies for victims of ID theft.
- **Deterrence and enforcement** -- The lack of criminal laws prohibiting ID theft and the limited resources of law enforcement authorities may mean that there is insufficient deterrence. Member countries could explore the value of increasing resources for law enforcement, ID theft investigations and training. More generally, given the rapid evolution of ID theft techniques and methods, more resources and training could be granted to all OECD authorities involved in the battle.
- *Education* -- Consideration could be given to broadening education on ID theft so as to cover all interested stakeholders including consumers, users, governments, businesses, and industry.
- **Co-ordination and co-operation** -- Agencies involved in the enforcement of anti-ID theft rules and practices are numerous at both domestic and international levels. Their respective roles and framework for co-operation could be clarified to help enhance their effectiveness. Consideration could be given to improving domestic law enforcement co-ordination by developing national centers dedicated to the investigation of ID theft crimes. With regard to co-ordination and co-operation with foreign law enforcement authorities, member countries could explore areas of mutual interest, such as *i*) enhancing deterrence, *ii*) expanding participation in key international instruments (*e.g.* the Council of Europe Convention on Cybercrime), *iii*) improving response to requests for investigative assistance, and *iv*) otherwise strengthening co-operation with foreign partners (*e.g.* in the fields of training law enforcement).

#### **INTRODUCTION**

#### A. A new Internet landscape

Over the past ten years, the Internet has evolved into a single and integrated infrastructure where audiovisual media, publishing, and telecommunications are all converging. This low-cost and seamless communications system not only fosters growth for existing and new industries but also serves society by promoting diffusion of culture and knowledge. Today, the Internet is enhancing commercial opportunities for businesses. It is also serving as a vehicle for providing public services directly to businesses and consumers, as well as innovative personal and social activities. As such, the Internet has substantially changed both our global economy and society and its impact in the coming years is expected to be significant.

Anticipating this evolution, as early as in 1998,<sup>1</sup> the OECD pointed out the importance of sustainable electronic transactions for the global economy and society. At the same time, however, it warned its member economies about the dangerous sides this changing scheme could bring, one of them being the emergence of new types of online threats to the detriment of consumers and users. By nature, face to face client-relationships are nonexistent on the Internet. Establishing one's real identity for online transactions is complicated, thereby making fraud easier.

#### The Ministerial Conference on the Future of the Internet Economy

OECD member countries have understood the need to better address the challenges arising from misuse of the Internet. At its October 2005 meeting, the OECD's Committee for Information, Computer and Communications Policy ("ICCP") agreed to conduct future work that would analyse broad trends and policies that will shape the future of the Internet economy. It further agreed that the issues surrounding the future of the Internet would benefit from a Ministerial-level Conference on the *Future of the Internet Economy*, to be held on 17-18 June 2008 in Seoul, Korea.

#### **CCP** involvement

The "*Future of the Internet Economy*" project was initially presented to the Committee on Consumer Policy ("CCP") at its October 2005 and March 2006 meetings, with an invitation to participate. Recognising the close synergies with its past and future work programme in relation to this issue, the CCP, at its 72<sup>nd</sup> session in October 2006, agreed to provide input to the project. Cyber fraud was identified as the main theme to be examined, with a particular focus on:

- ID theft.
- Mobile commerce.

- User education and empowerment.
- Cross-border law enforcement co-operation.
- Redress for individual victims on-line.

#### **B.** A scoping paper on online identity theft

Unlike most of the subject areas identified above, ID theft is a new topic for the CCP to explore. While this issue is indirectly covered by the *1999 OECD Guidelines for Consumer Protection in the Context of Electronic Commerce* ("The 1999 *E-commerce Guidelines*") (OECD, 1999), and the *2003 OECD Guidelines for Protecting Consumers from Fraudulent and Deceptive Commercial Practices Across Borders* ("The *2003 Cross-border Fraud Guidelines*") (OECD, 2003), it has never been as such the subject of an in-depth study by the Committee. In light of the growing importance of this issue, at its 72<sup>nd</sup> session, the CCP requested the Secretariat to prepare the present analysis of online ID theft, to better understand the concept and the extent to which it can affect consumers and users.

#### A cross-cutting issue

ID theft is a cross-cutting problem which does not only violate consumer protection rules, but also security, privacy, and anti-spam rules. Considering how best ID theft could be countered should be done under a multi-disciplinary approach. Thus, in preparing this paper, the CCP Secretariat consulted with the Secretariat to the OECD Working Party on Information Security and Privacy ("WPISP"). The WPISP itself developed an analytical report on malware in partnership with the Asia-Pacific Economic Co-operation Telecommunication and Information Technology Working Group ("APEC TEL") Security and Prosperity Steering Group ("SPSG") (OECD, 2008). The CCP Secretariat also established contacts with the OECD's Working Party on Indicators for the Information Society ("WPIIS") to examine how statistics could better measure online ID theft cases.

#### Background on ID theft in the online environment

Over the past ten years, business-to-consumer ("B2C") electronic transactions have increased. Numerous factors can help explain the increase: most firms in the OECD area have now a presence on the Net; in particular, financial institutions offer online banking services to their customers; finally, as consumers get more experienced in buying goods or services on-line, they become more aware of how to avoid e-scams. As a consequence, hardly any business wanting to benefit from commercial opportunities can today afford to remain present solely in the offline world.

However, despite its potential, the growth of the E-commerce market is somewhat restrained (OECD, 2006c).<sup>2</sup> This is particularly true in the European Union ("EU"). As noted in the *EU 2006 Special Eurobarometer* (EC, 2006, p. 12), only 27% of the EU population purchased goods and services online over the past year, and mostly on a domestic basis. One of the main reasons explaining this limited popularity is a continuing lack of full consumer confidence in the E-marketplace. The new commercial opportunities offered by the Internet have proved to be prone to inherent risks. Those risks have taken the form of sophisticated frauds which may affect consumers and users very quickly and on a global scale, while allowing perpetrators to escape detection.

Other statistics also indicate a decline in consumer confidence in E-commerce. In a 2006 online survey conducted by the Business Software Alliance and Harris Interactive, nearly one in three adults said

that security fears compelled them to shop online less, or not at all, during the 2005-2006 holiday season (US IDTTF, 2007, Vol. I, p. 11). Similarly, a Cyber Security Industry Alliance survey in June 2005 found that 48% of consumers avoided making purchases on the Internet because they feared that their financial information might be stolen (US IDTTF, 2007, Vol. I, p. 11-12). Although the studies have not correlated these consumer attitudes with online habits, these surveys indicate that security concerns likely inhibit E-commerce.

ID theft is regarded by many as one of the major risks consumers and users are exposed to in today's digital environment. E-payment and e-banking services, on which this report will mainly focus, substantially suffer from such mistrust. In the United Kingdom, for example, an estimate of 3.4 million people were prepared to use the Internet but not willing to shop online because of a lack of trust or fears about personal security (UK OFT, 2007, p. 6). Many member countries have noted the problem and taken steps to help ensure that consumers and users are adequately protected against ID theft. These steps encompass various actions and measures such as consumer and user awareness campaigns, new or adapted legislative frameworks, private-public partnerships, and industry-led initiatives aimed at putting in place technical prevention measures and responses to the threat.

Despite these initiatives however, many member countries have not sufficiently addressed the problem of ID theft. As a result, its scope, magnitude and impact may vary from one country to another, or even from one source to another within the same country. These differences reflect the need for a more co-ordinated response at both domestic and international levels.

Section I of this paper examines the multiple facets of the ID theft problem and reviews the different legal approaches adopted among OECD member countries to reduce its incidence.

Section II focuses on the different methods used to perpetrate ID theft *via* the Internet. It describes the techniques implemented by ID thieves to lure victims online, which increasingly involve the use of spam and malware.

Section III describes the various forms of ID theft, ranging from misusing existing accounts or opening new accounts to brokering personal data and fraudulently obtaining government services, benefits, or documents.

Section IV provides a profile of ID theft victims. It draws on the available statistical data reflecting victims' complaints and losses trends. It questions whether ID theft is more prevalent off than on-line.

Section V sets out OECD member country and international enforcement efforts aimed at stemming online ID theft.

This report addresses issues and concepts of a technical nature which might evolve rapidly. The law may have changed since first publication, and the reader is cautioned accordingly.

#### SECTION I. ID THEFT'S CHARACTERISTICS

There is no standard definition of on or offline ID theft at the international level. While some countries have adopted a broad view of the concept, which usually applies to both on and offline ID theft, very few consider it as a specific offence. As a result of these different approaches, the legal nature of ID theft varies from one jurisdiction to another, leading to the application of different regimes of prevention, prosecution and sanctions.

ID theft is an illicit activity with multiple facets. It is generally included in a larger chain of wrongs or crimes. More specifically, ID theft is committed over different sequences of actions. This complexity has opened the path for different legal categorisations of the concept in OECD member countries, which either qualify ID theft as a specific crime, a civil wrong, or as a preparatory step in the commission of other offences such as fraud, forgery, terrorism, or money laundering (see Annex II).

In the absence of a globally accepted definition, this paper will use the term "ID theft" as follows:

ID theft occurs when a party acquires, transfers, possesses, or uses personal information of a natural or legal person in an unauthorised manner, with the intent to commit, or in connection with, fraud or other crimes.

Although this definition encompasses both individuals and legal entities, focus in the present paper is limited to identity theft affecting consumers.

While some OECD member countries employ different terminology to describe the problem,<sup>3</sup> all of the countries addressing the issue aim to prevent fraudulent or criminal activity resulting from the misuse of personal information.<sup>4</sup>

#### A. How does OECD domestic legislation cover ID theft?

As described below, few OECD member countries have adopted legislation which specifically addresses ID theft. In most other countries, it is a constituent element of common wrongs, and as such it is covered by a multitude of rules including unlawful access to data, fraud, forgery, and intellectual property rights, *etc.* ID theft is also a facilitating factor to commit other, more serious offences. In such a case, it is often "absorbed" by the more serious offence. The transition of traditional forms of ID theft to the electronic marketplace raises the question of whether existing OECD member countries' legislative schemes are sufficient to address the problem.

The following discussion illustrates differences in some OECD member countries' approaches.

#### ID theft is a specific offence

In the United States, under Federal and various state laws, ID theft is a specific criminal offence that can occur when someone "knowingly transfers, possesses, uses, without lawful authority, a means of identification of another person with the intent to commit, or in connection with, any unlawful activity that constitutes a violation of Federal law, or that constitutes a felony under any applicable State or local law." <sup>5</sup> As such, ID theft is a crime *per se*. In 2004, the *Identity Theft Penalty Enhancement Act* ("ITPEA") introduced aggravated penalties.<sup>6</sup>

#### ID theft is a constituent element of other wrongs or crimes

Until recently, fraud in the United Kingdom was not regarded as a specific offence. However, under the UK *Fraud Act 2006*, which came into force on 15 January 2007,<sup>7</sup> fraud has become a single statutory offence which extends to fraud committed online. Fraud can be committed in the three following ways: *i*) by making a false representation (dishonestly, with intent to make a gain, cause loss or risk of loss to another); *ii*) by failing to disclose information; and *iii*) by abuse of position. In addition, new offences were established such as: the act of "obtaining services dishonestly … if payment is made for them," such as credit card fraud over the Internet; the act of possessing "articles for use in frauds" (the term "article" including "any program or data held in electronic form"), which relates to ID fraud; and the act "for making or supplying articles for use in frauds… knowing that it is designed or adapted for use … in connection with fraud," which relates to the writing of malicious software.<sup>8</sup>

In Australia, except in Queensland<sup>9</sup> and South Australia,<sup>10</sup> ID theft is not a stand-alone offence. However, identity crime and identity security have increasingly become a priority for the Australian Government since 2000, with the tabling of the *Numbers on the Run* report by the House of Representatives Standing Committee on Economics, Finance and Public Administrations. In July 2004 the Australian Standing Committee of Attorneys General ("SCAG") agreed to the development of model identity theft offences. A Discussion Paper on model identity crime offences was developed and approved by SCAG at their April 2007 meeting.<sup>11</sup>

On 21 November 2007, the Government of Canada introduced a new bill making ID theft a specific criminal offence. While the misuse of someone's identity information is covered in the *Criminal Code* by offences such as impersonation and forgery, the preparatory steps of collecting, possessing and trafficking in identity information are generally not captured by existing offences.<sup>12</sup>

To date, except for the United Kingdom, no specific provisions about ID theft or ID fraud may be found in EU Member States' laws. In France, in 2005, a legislative proposal was put forward before the

Senate (high chamber of the French Parliament) to specifically prosecute online ID theft. However, in October 2006, the French Minister of Justice rejected this proposal<sup>13</sup> stating that ID theft (whether committed on or off-line) is adequately sanctioned under French law through various criminal and civil wrongs such as the use, without authorisation, of someone's name, if such a use exposes the victim to criminal sanctions (Article 434-23 of the French Criminal Code), fraud ("*escroquerie*" – Article 313-1 of the French Criminal Code), or defamation (Article 131-12 *et al.* of the French Criminal Code).

#### The option of criminalising ID theft in OECD member countries

Would criminalisation improve OECD member countries' fight against ID theft? As described above, some countries argue that even though ID theft is not an offence *per se* under their legislation, it is already adequately covered by various provisions relating to data privacy, security or frauds, which may be of a criminal nature. Others however consider the option of criminalisation as a helpful means to better stem the threat.

The UK Credit Industry Fraud Avoidance Service ("CIFAS") sees "the criminalisation of ID theft through sections 25 and 26 of the UK *Identity Cards Act 2006* and through the Fraud Bill" as a progress. CIFAS takes the view that, before criminalisation, fraudsters could well perceive "ID fraud as an excellent avenue to financial gain precisely because they knew that the police was unlikely to pursue them" (CIFAS, 2006, p. 5). It considers that this will create incentives for all stakeholders to understand the specificity of the problem: the Police will intervene and investigate more ID theft cases; the victims will receive a voice and the needed recognition that they are victims of a crime (INTERVICT, section 7.3); penalties will be increased to address the issue more aggressively.

In Canada, the proposed Identity Theft bill aims at filling a gap in the *Criminal Code*, to help ensure that the preparatory steps of collecting, possessing and trafficking in identity information were generally not captured by existing offences. Under the new legislation, each of the three offences created is subject to five-year maximum sentences.

The US Identity Theft Task Force supports the effort to encourage other member countries to enact suitable legislation criminalising ID theft. Since ID theft is a global problem, providing assistance to, and receiving assistance from, foreign law enforcement agencies is critical. In cases where the foreign country does not have laws criminalising ID theft, it impedes the investigating country's ability to collect evidence and prosecute ID theft crimes that have foreign components (US IDTTF, 2007, Vol. I, p. 59-60).

In addition to enacting legislation that creates specific criminal offences for ID theft, OECD member countries could adopt a multi-faceted approach including, for example, legislation on data security breach notification<sup>14</sup> and public-private initiatives to develop a comprehensive solution to the ID theft problem.

## B. ID Theft's main elements

#### The concept of "identity" and "personal information"

ID theft is a problem involving personal information. Our society is increasingly relying on personal information to identify individuals in many circumstances. For instance, it is used to establish accounts with merchants, ISPs, phone companies, *etc.* It may also be used to get access to various accounts and

record systems with financial institutions, health organisations, schools, government agencies, and other entities.

Understanding the concept of "identity" and how its components operate in different media is crucial to determine the appropriate means to protect it. The core components of identity are relatively easy to grasp. They are generally based on fixed and verifiable attributes which are usually officially provided and registered by public authorities.<sup>15</sup> These attributes include individuals' gender, first and last name, date and place of birth, parents' first and last name and in some countries, individuals' assigned social security number.<sup>16</sup> Individuals also can be identified with a variety of other attributes including a computer username and password, a web page, a blog, an Internet Protocol ("IP") address that identifies computers on the Internet, an e-mail address, a bank account and PIN number.

An effective fight against online ID theft will be difficult if the ways in which the different components of identity are used in the online medium are not defined. As concluded in a 2006 *Security Report on Online ID theft*, "after all, we cannot protect what we cannot define," (BT, 2006). Responding to this issue is thus a first essential step to determine how digital personal information can be made harder to steal. In Korea, an improved online identity system was introduced in October 2006 to help verify Korean citizens' identity in cyberspace.<sup>17</sup> The old 13-digit citizen registration number, which contains Korean citizens' personal information, was used as an identity verification means online. However, this number, which was stored on firms' online databases, had been the subject of numerous thefts.<sup>18</sup> The Korean authorities thus decided to replace it by a new i-PIN number which does not contain any personal data and can be replaced in the event someone's i-PIN number has been copied or misused.

# ID theft as a means to commit fraud or other crimes<sup>19</sup>

In most cases, perpetrators involved in this illicit activity aim at engaging in a variety of other wrongs for different purposes including obtaining credit, money, goods, services, employment benefits, or anything else of value to be used in the name of the victim, without consent.

ID thieves may sometimes not use the victims' identity themselves to commit fraud. Instead, they will sell it to other parties who will themselves commit fraud, or generate new illegal forms of personal identity (such as a birth certificate, driver's license, or a passport).

According to a 2004 US victimisation survey conducted by the Identity Theft Resource Centre ("ITRC"), the most prevalent form of ID theft was in majority financial (66 %), financial and criminal (9%), and financial, criminal and cloning (6 %) (ITRC, 2005, p. 6). Economic and financial fraud committed by the use of credit cards has clearly profited from technological advances. Due to the growing number of people using electronic payment systems, this kind of fraud could propagate further in the coming years.

#### SECTION II. THE ONLINE ID THEFT TOOLKIT

ID theft is an illicit activity with a long history that predates the Internet. Typically, conventional ID theft was – and still is – committed through techniques such as dumpster diving (also known as "bin raiding");<sup>20</sup> payment cards' theft; pretexting,<sup>21</sup> shoulder surfing;<sup>22</sup> skimming;<sup>23</sup> or computer theft.

In recent years, these activities have been given a modern spin through the fast development of the Internet, which, as examined below, allows ID thieves to install malware on computers, and to use a luring method known as "phishing," which itself can be perpetrated through the use of malware and spam.

# A. ID theft based on malware only<sup>24</sup>

Malware is a general term for a software code or programme inserted into an information system in order to cause harm to that system or to other systems, or to subvert them for use other than that intended by their own users. With the rise of stealthy malware programs such as "keystroke loggers," viruses or "Trojan"<sup>25</sup> that hide on a computer system and capture information covertly, malware is increasingly used as a standalone technical tool to steal victims' personal information.

ID thieves use various malware threats, including blended and targeted attacks, to obtain consumers' personal information.

#### Blended attacks (hidden)

Most malicious activity now combines several malware applications to carry out attacks. This has resulted in a change in landscape as blended malware attacks use techniques such as social engineering to circumvent established defences. One type of blended attack occurs for instance when malicious actors embed malware into a website that is otherwise legitimate.

#### Targeted attacks (hidden and/or self announcing)

Most targeted attacks notably seek to steal an entity's intellectual property and proprietary data. Because users throughout the world have taken more proactive steps to protect their systems, attackers have moved away from large scale attacks that seek to exploit as many occurrences of vulnerability as possible, to smaller more focused attacks. Targeted attacks often allow attackers to remain undetected by security measures (anti-virus software and firewalls), and maintain privileged access to a user's system for longer periods of time.

#### B. Phishing

The concept of "phishing" is not clearly and consistently defined in OECD member countries. Some law enforcement authorities or industry often use it as a synonym of ID theft. Others distinguish the two notions. As stated in the *OECD Anti-Spam Toolkit of Recommended Policies and Measures* (OECD, 2006c, p. 25), phishing is considered as the main method enabling cyber crooks to commit ID theft.

#### Background

Phishing is a term that was coined in 1996 by US hackers who were stealing America Online ("AOL") accounts by scamming passwords from AOL users. The use of "ph" in the terminology traces back in the 70's to early hackers who were involved in "phreaking," a hacking of telephone systems.

Phishing is today generally described as a luring method that thieves use to fish for unsuspecting Internet users' personal identifying information through e-mails and mirror-websites which look like those coming from legitimate businesses, including financial institutions, or government agencies. As shown in Figure 1 below, a well-known phishing e-mail is the one pretending to be from a bank to customers asking for their account details. In France, for instance, in 2005, a one-stop-shop phishing scam targeted four banks' customers.

Another well known phishing e-mail is the so-called "419 scam"<sup>26</sup> (also known as the "Nigerian scam" or offline as the "Nigerian letter"), through which phishers try to commit advance fee fraud by requesting upfront payment or money transfer from their targets. Phishers usually offer their potential victims to share with them a large amount of money that they want to transfer out of their country. Victims are then asked to pay fees, charges or taxes to help release or transfer the money. Victim of its own success, this scam is today very well known among Internet users and is not used as much anymore.

Other examples of phishing e-mails or fake websites are collected and stored by the Anti-Phishing Working Group ("APWG"), an industry association aimed at eliminating ID theft and fraud resulting from phishing. The consortium, which serves as a forum where industry, business and law enforcement agencies discuss the impact of phishing, maintains a public website allowing its members to share information and best practices for eliminating the problem.<sup>27</sup>

#### Scope

#### A social-engineering scheme

Phishing originally entailed deceptive attacks using deceptive or "spoofed"<sup>28</sup> e-mails and fraudulent websites hijacking brand names of banks, e-retailers and credit card companies, with a view to deceiving Internet users into revealing personal information (OECD, 2005, p. 23). Classic phishing attacks through e-mail can be typically described as follows:

- **Step 1.** The phisher sends its potential victim an e-mail that appears to be from this person's bank, or some other organisation that would hold personal information. The phisher in his scam carefully uses the colours, graphics, logos and wording of an existing company.
- **Step 2.** The potential victim reads the e-mail and takes the bait by providing the phisher with personal information by either responding to the e-mail or clicking on a link and providing the information via a form on a website that appears to be from the bank or organisation in question.
- **Step 3.** Through this fake website or e-mail, the victim's personal information is directly transmitted to the scammer.

#### A technical subterfuge scheme

Like the Nigerian scam, the classic phishing attack described above is nowadays well known and fraudsters have developed more sophisticated phishing variants which are more difficult to detect, if at all possible. These variants rely on specific techniques such as malware or/and spam.

In light of the above preliminary findings, phishing may be generally described as follows:

#### Box 1. Phishing process

- Phishing is perpetrated through the sending of spoofed e-mail or fake websites that trick users into disclosing their
  personal information and enable fraudsters to commit ID theft.
- Frequently, these messages, or the websites that they link to, try to install malicious code (OECD, 2006c, p. 25).
- Examples of the type of information sought by "phishers" include credit card and PIN numbers, account names, passwords, or other personal identification numbers.
- Phishers use victims' personal information to conduct unlawful activity, typically fraud.

#### C. Phishing techniques

Increasingly, ID theft is perpetrated using malware or "crimeware" (Radix Lab, 2006, p. 4). It is also propagated through spam messages, which often themselves contain malware.

#### Phishing based on malware

Although malware is not the only means by which computers can be compromised, it provides the attacker convenience, ease of use, and automation to conduct attacks on a large scale that would not otherwise be possible due to lack of skill and/or capability. Some forms of automated phishing can be illustrated by the following attacks:

#### "Pharming"

Malware-based phishing attacks can take various forms. A typical malware-based phishing attack is often illustrated by the technique known as "pharming" (or "warkitting"<sup>29</sup>) which uses the same kind of spoofed identifiers as in a classic phishing attack, but which, in addition, redirects users from an authentic website (from a bank for instance) to a fraudulent site that replicates the original in appearance. When a user connects its computer to, for instance, a bank web server, a hostname lookup is performed to translate the bank's domain name (such as "bank.com") into an IP address containing several digits (such as 138.25.456.562). It is during that process that crooks will interfere and change the IP address.

#### "Man-in-the-middle attack"

Another example of malware-based phishing can be illustrated by the so-called "man-in-the-middle attack." This expression describes the process by which the phisher collects personal data through the interception of an Internet user's message that was intended to be sent to a legitimate site.

In today's convergent Internet, two other techniques, relying on non-computer devices, have been recently used by phishers to perpetrate ID theft.

## "SMiShing"

Phishing continues to spread by reaching external devices such as mobile phones. Through this emerging technique, cell phone users receive text messages ("SMS") where a company confirms to them that they have signed up for one of its dating services and that they will be charged a certain amount per day unless they cancel their order at the company's website. Such a website is in fact compromised and used to steal the unsuspected user's personal information. As reported by McAfee Avert Labs in August

2006, SMiShing for the first time targeted two major mobile phone operators in Spain in 2006. The scam used the two companies' own system to send texts to customers offering free anti-virus software purporting to come from the phone operator. When customers followed the link to install the software onto their computers, these were infected with malicious programs.<sup>30</sup> McAfee predicts that although recent, the threat of SMiShing, which is now part of the "cybercrime toolkit," will increasingly be used by malware perpetrators in the coming months (McAfee, 2006, p. 20).

#### "Vishing"

Voice over Internet Protocol ("VoIP") is also a new technique using phones to steal individuals' personal information. Through this means, the phisher sends a classic spoofed e-mail, disguised so as to appear from legitimate businesses or institutions, which invites the recipient to call a telephone number. Victims feel usually safer in this way as they are not required to go to a website where they would transmit their personal information. When calling, the target reaches an automated attendant, prompting her to enter personal information such as account number, password or other information for pretended "security verification" purposes. In some cases, the phisher skips the e-mail altogether and cold calls consumers, fishing for financial information.

The above described techniques based on malware are evolving and transforming into new kinds of threats on a rapid basis. They can even be mixed, as noted in 2005 by the US Identity Theft Technology Council ("ITTC") report on *Online Identity Theft* (ITTC, 2005, p. 7). The ITTC reports that "the distinctions between [phishing] attack types are porous, as many [of them] are hybrid, employing multiple technologies." The report illustrates this with the example of a deceptive phishing e-mail which could direct a user to a site that has been compromised via content injection, and which then installs malware that poisons the user's hosts file. As a result, subsequent attempts to reach legitimate websites would be rerouted to phishing sites, where confidential information is compromised using a man-in-the-middle attack. This hybrid attack includes a pharming and man-in-the-middle attack.

#### Phishing vehicled through spam

Spam is another vector used for sending massive phishing hits. As described in the OECD *Anti-Spam Toolkit* (OECD, 2006c, p. 7), spam began as electronic messages usually advertising commercial products or services. Over the past few years, spam has evolved from inoffensive advertising to potentially dangerous messages which can be deceptive and may result in ID theft.

While spam messages used to be mostly text-based, they increasingly contain images. The security company adds that while spammers traditionally used well-known top level domain names such as ".com," ".biz" or .info", they now attempt to avoid detection by using domain names from small island countries, such as ".im" from the UK Isle of Man; these lesser-known domain names are often not included in spam filters (McAfee, 2006, p. 15).

#### Spam, phishing, and malware

Although the techniques are different, spam and malware are now increasingly combined as key underpinnings of the illicit techniques fraudsters use to commit ID theft. As shown in Box 2 below, spam often distributes malware or direct users to infected sites aimed at creating new infected computers (OECD, 2006b).

#### Box 2. The *Haxdoor* Example

A series of identity theft Trojan attacks were directed against Internet users in Australia between March and August 2006. Attackers used spam that contained embedded links to malicious sites to conduct the attacks. When users clicked on the link provided in the spam e-mail, they were sent to a URL containing a commercial malware kit known as WebAttacker. WebAttacker then scanned the computer system to determine which exploit would be most effective in compromising the system. Once WebAttacker determined the proper exploit, the user was directed to another webpage within the same domain and a Trojan known as "Haxdoor" was downloaded. Haxdoor then disabled various security counter-measures so that when the users visited websites, Haxdoor began capturing passwords and other data. The data captured by Haxdoor was then sent to a domain registered to the attacker. The attacker used this domain to harvest the data on a periodic basis. In one case, a computer belonging to a company in Australia was compromised by Haxdoor for approximately 14 weeks and 3 days. During this time, the attacker was able to log the individual's personal data including credit card details as well as personal information for other employees in the company.

#### **D.** Phishing evolution and trends

Today's ID theft perpetrators are viewed as professionals. They seem to increasingly belong to organised groups which use ID theft to commit other serious crimes such as drug trafficking, money laundering, vehicle theft and illegal immigration (McAfee, 2007, p. 10; UN IEG, 2007). Their illicit actions can remain unsuspected in many cases as they are more and more relying on the help of "innocent" intermediaries, such as students.<sup>31</sup> Moreover, they become ever more sophisticated.

#### More sophisticated and tailored attacks

At the origin of the phenomenon, ID theft messages were poorly designed. They included signs of weaknesses such as: rudimentary textual errors; English-language in messages addressed to non-English individuals (as illustrated in Figure 1 above).

In contrast, today's phishing scams contain well designed logos and typical messages that appear to be from real companies or institutions (see Figure 2 below). To fight against this threat, in the United States, the Intellectual Property Governance Task Force<sup>32</sup> has been created to encourage trademark owners to employ technical measures to prevent their brands from being abused by phishers.

#### More targeted attacks


While continuing to target high-profile banks and e-commerce sites, phishers now try to reach fewer victims, but in more personalised ways, thereby potentially becoming even more dangerous. McAfee's 2006 *Virtual Criminality* report (McAfee, 2006, p. 11) reveals that fraudsters are changing the content of their phishing mails away from "update your details now" scams to more tailor-made messages.

They can also send false personalised e-mails to other small groups such as employees through a technique known as "spear-phishing." In such a case, the sender impersonates a colleague or the employer to steal employees' passwords and username and to ultimately gain access to the employees' company's entire computer system.

#### Phishing trends

Phishing is considered as a serious threat that is on the rise. A large and diverse population of fraudsters ranging from expert hackers to inexperienced individuals who can even purchase phishing kits on line have exploited the Internet and other technological tools to wreak havoc on innocent victims.<sup>33</sup>

In 2006, the Netcraft toolbar, an anti-phishing tool developed by the Netcraft toolbar Community,<sup>34</sup> blocked more than 609 000 confirmed phishing URLs, a substantive jump from only 41 000 in 2005.<sup>35</sup> Netcraft views this dramatic surge, mainly concentrated in November – December 2006, as the result of recent techniques implemented by phishers to automate and propagate networks of spoof pages, enabling the rapid deployment of entire networks of phishing sites on cracked web servers.<sup>36</sup>



The Anti-Phishing Working Group's ("APWG") November 2006 *Phishing Activity Trends* report confirms a jump in cyber attacks from July to November 2006 (APWG, 2006a). In November 2006, 37 439 new phishing sites were detected, a 90% increase since September 2006. However, in its December 2006 report (APWG, 2006b), the APWG notes a decrease in the number of new phishing sites (which dropped to 28 531).

According to the APWG's April 2007 statistics (APWG, 2007), as shown in the pie chart below, phishing websites that host malicious code or have Trojan downloads are hosted in several different countries, with the most websites hosted in the United States (38.57%), followed closely by China (37.64%), and Russia (8.87%).

#### SECTION III. THE DIFFERENT FORMS OF ID THEFT

Once ID thieves obtain victims' personal information, they misuse it in a variety of ways. The US FTC's 2006 Identity Theft Survey Report classifies ID theft victims in one of the three main following categories: *i*) New Accounts (such as new credit card, bank accounts, or loans) and Other Frauds (such as obtaining medical care); *ii*) misuse of Existing Non-Credit Card Accounts; or *iii*) misuse of Existing Credit Cards Only (US FTC, 2007c, p. 12).<sup>37</sup> The most commonly reported forms of misuse of both existing credit card and non-credit card accounts perpetrated by means of ID theft were as follows (US FTC, 2007c, p. 17):

- Credit card fraud (61%).
- Checking or savings accounts (33%).
- Telephone service accounts (11%).
- Internet payment accounts (5%).
- E-mail and other Internet accounts (4%).
- Medical insurance (3%).
- Others (1%).

As reflected above, credit card fraud is the most common form of misuse of existing accounts. This form of ID theft occurs when the ID thief obtains the actual credit card, the numbers associated with the account, or the information derived from the magnetic strip on the back of the card. Since credit cards can be used remotely, for example via the Internet, ID thieves are often able to commit fraud without physically possessing the victims' credit card.

ID thieves also commit new account fraud by using the victims' personal information to open an account, incur excessive charges, and then disappear. Victims often do not discover the ID theft until they are contacted by a debt collector or denied a job, loan, car, or benefit because of a negative credit rating. In some instances, ID thieves deposit stolen or counterfeit cheques, or cheques drawn on insufficient funds,

and withdraw cash, causing immediate financial harm that is typically in large amounts (US IDTTF, 2007, Vol. I, p. 19-20). Although this form of ID theft is less prevalent, it can cause more financial injury, is less likely to be discovered quickly, and requires the most time for victim recovery. Indeed, the US FTC's *2006 ID Theft Survey Report* indicates that 24% of New Accounts and Other Fraud victims did not find out about the misuse of their information until at least six months after it started – compared to just 3% of Existing Credit Cards Only and Existing non-Credit Card Account victims. In the Existing Credit Cards Only and Existing Non-Credit Card Accounts categories, the median amount of time that elapsed before victims discovered that their personal information was being misused was between one week and one month. For the New Accounts & Other Frauds category, the median value was between one and two months (US FTC, 2007c, p. 24).

Some 17% of ID theft victims reported that the thief used the victim's personal information to open at least one new account. The most common type of accounts victims reported thieves opening were as follows (US FTC, 2007c, p.19):

- Telephone service accounts (8%).
- Credit card accounts (7%).
- Loans (3%).
- Cheque / savings (2%).
- Internet payment accounts (2%).
- Auto insurance (1%).
- Medical insurance (0.4%).
- Other accounts (2%).

Some 12% of victims reported that their personal information was misused in non-financial ways (US FTC, 2007c, p.21). The most common such use, which was reported by 5% of victims, was the use of the victim's name and identifying information when the ID thief was stopped by law enforcement authorities or charged with a crime. Other increasingly popular forms of ID theft include the misuse of personal information to obtain passports or government ID numbers (social security numbers in the United States), particularly by illegal immigrants, fraudulent requests for taxpayer refunds, and health care fraud. In particular, health care fraud may put victims at risk of receiving improper medical care due to inaccurate entries in their medical records, or having their medical insurance coverage depleted by the ID thief (US IDTTF, 2007, Vol. I, p. 20).

ID thieves may also use victims' personal information to engage in data brokering. For example, certain websites, known as "carding sites," traffic stolen credit card data all over the world. The US Secret Service estimates that the two largest current carding sites collectively have nearly 20 000 member accounts (US IDTTF, 2007, Vol. I, p. 20).

#### SECTION IV. THE VICTIMS

Determining the impact of online ID theft is a challenging exercise. As mentioned earlier, the absence of a common legal approach to criminalising ID theft complicates matters. As a result, data measuring the extent to which ID theft can be harmful presents significant weaknesses which distort the way in which the problem may be perceived. They concern a limited number of OECD member countries (including Australia, Canada, Korea, the United States, and the United Kingdom,) and may not be indicative of the situation in other countries or regions such as the EU.

#### Box 3. Measurement of ID theft's impact on victims: data limitation

- Statistics do not provide a clear picture of the notion of "victims" which either covers individuals, governments, international organisations, business and/or industry, or the economy as a whole.
- Statistics do not measure the same types of frauds or crimes and are thus incomparable.
- Statistics gathered by public authorities for policy purposes vary from those collected by private businesses for commercial purposes.
- Direct and indirect losses data do not cover all victims and all types of ID theft cases.
- Statistics do not cover all OECD member countries.

#### A. The "victims" concerned

#### Complaint data

The category of ID theft victims could *a priori* be limited to those individuals whose personal information was misappropriated by a party, and who subsequently suffered from economic or other sorts of harms. Complaints data cover this type of victim.

According to research conducted by the Canadian Fraud Prevention Forum in 2003, the impact of ID theft in Canada extended to victims across all ages, regardless of income and levels of education (BWGCBMMF, 2004, p.4). In May 2006, over 20 000 individual phishing complaints were reported in Canada, an increase of over 34% from the previous year.





Figure 5. Identity theft complaints by victim age

The US FTC's *Consumer Sentinel*<sup>38</sup> 2007 report on *Consumer Fraud and Identity Theft Complaint Data* (US FTC, 2007b) confirms this finding. As illustrated in Figure 5 below, of the people who reported

their age in their ID theft complaints, young people aged between 18-29 years experienced most ID theft (29%) in 2006, followed by persons aged 30-39 (23%).

The above complaints data only reflect reported cases, and do not illustrate the fact that in reality, the concept of victim is more complex. For example, complaint data do not always reflect that businesses and institutions are also victims of ID theft. In some instances, ID thieves may misuse a customer's banking account, or may use a bank's brand name in a phishing cyber attack to steal money from one of its customers. In such a case, the bank will also be the victim of ID theft inasmuch as it would have to reimburse the sum lost to its customer.<sup>39</sup>

#### ID theft data covering certain types of frauds

Data based on the various legal formulations of ID theft are not indicative of all ID theft cases. Since ID theft sometimes refers to a crime or is absorbed in other types of frauds, data reflecting these different realities are incomplete and do not correspond from one country to another. Consequently, data are not easy to compare, if at all possible.




Figure 6. Sentinel complaints by calendar year

According to the US FTC, in 2006, for the sixth year in a row, ID theft topped the list of consumer complaints, accounting for 246 035 of more than 674 354 fraud complaints filed with the agency (see Figure 6 below).

The above *Consumer Sentinel* figure shows that complaints data can be classified in two categories: ID theft complaints and fraud complaints. Fraud complaints can be further broken down into Internetrelated fraud complaints and other fraud complaints. However, the ID theft complaints, which are complaints involving the misuse of personal information to commit fraud, are not segregated based on whether the ID theft was perpetrated through the use of the Internet.

#### Divergent public and private data

There are substantial differences between statistical information gathered by public authorities for policy purposes and by private businesses for commercial purposes.

On the one hand, some security vendors state that the scale of the threat has gone down in the past years and that consumer confidence is now on the rise. Likewise, some financial institutions, which say that the costs are relatively modest, are not willing to reveal their own financial losses. On the other hand, other private bodies advance figures reflecting an increase in ID theft.

The US FTC's 2003 ID Theft Survey Report (US FTC, 2003, p. 4) indicated that ID theft affects approximately 10 million Americans each year and that a total of 4.6% of survey participants experienced ID theft in 2002. The 2006 ID Theft Survey Report (US FTC, 2007c, p. 4) found that approximately 8.3 million US adults discovered that they were victims of ID theft in 2005 (a total of 3.7% of survey participants).<sup>40</sup> In 2007, Javelin Identity Fraud Survey Report funded by Visa, Wells Fargo and CheckFree,<sup>41</sup> found that ID fraud had fallen about 12% over a year, translating into a total fraud reduction of USD 6.4 billion.

However, the Javelin report was criticised and regarded as trying to persuade the opinion that "business are doing an adequate job in protecting consumers' personal information and that the onus in on consumers to better protect themselves."<sup>42</sup> A 2007 McAfee survey noted this discrepancy, considering Javelin's percentages as "surprisingly low" (McAfee, 2007, p. 11) and comparing them to Gartner statistics, which, in contrast, in 2007, counted 15 million Americans as victims of ID theft.<sup>43</sup>

Adding to the confusion, some financial institutions even claim that none of their customers has ever been affected by a phishing attack, fearing damages to their reputation.<sup>44</sup>

#### B. Victims' direct and indirect losses

As mentioned above, ID theft is not a crime in itself under a vast majority of OECD member country legislation, the costs borne by victims are buried in statistics for various forms of frauds or crimes (UN IEG, 2007, p. 62). Moreover, data available alternatively refer to the costs borne by one country's economy, consumers, or consumers and business.

#### Victims' direct loss

In the United Kingdom, the Home Office estimates that ID fraud costs GBP 1.7 billion *to the UK economy*, compared to GBP 1.2 billion in 2002.<sup>45</sup> According to APACS, the UK payments association, online banking fraud continues to increase, costing the UK industry GBP 22.5 million in the first half of 2006, against GBP 14.5 million in the same period in 2005.

In the United States, according to Gartner 2007 statistics, the *average loss of funds in a case of ID theft* was USD 3 257 in 2006, up from USD 1 408 in 2005. In addition, the average loss in the opening of a fraudulent new account more than doubled over that time, from USD 2 678 to USD 5 962.<sup>46</sup> Based on the Javelin 2007 survey, ID theft is costing *the US industry and consumers* USD 49.3 billion annually.<sup>47</sup> According to a 2006 UK industry and law enforcement security report, in the United States, in 2005, 2.4 million consumers have reported losing money following a phishing attack (BT, 2006, p. 9).

In Australia, as reported by McAfee in 2007 (McAfee, 2007, p. 10), "[*estimates of the costs to the country's economy of ID fraud*] vary from less than USD 1 billion (from the Securities Industry Research Centre of Asia-Pacific) to more than USD 3 billion (Commonwealth Attorney-General's Department) per year."

According to a 2006 Computer Security Institute and FBI study surveying more than 600 US information technology ("IT") companies,<sup>48</sup> losses due to security incidents would have dropped by 18%, falling from USD 203 606 to USD 167 713. However, those incidents would still be significant, costing more than USD 52 billion to US IT companies.

The above variations in estimates raise the question of why data on direct losses attributed to victims of phishing vary so greatly. As observed in the *OECD Scoping Paper for the Measurement of Trust in the Online Environment*, "in part, this may be because financial institutions, while taking the threat seriously, are reluctant to publicly reveal their losses. In addition some firms may simply not know the scale of losses if they go unreported by their customers. Taken together, these factors may imply that it would be very difficult for the industry to determine a definitive figure for the direct financial losses attributable to phishing" (OECD, 2005, p. 25).

#### Victims' indirect loss

Victims' indirect loss can take many forms. Although there are not many statistics that clearly reflect the amount of indirect loss individual victims can suffer from ID theft, the US FTC and CIFAS have provided some guidance on this issue. According to the US FTC's 2006 Identity Theft Survey Report (US FTC, 2007c, p. 42), 16% of ID theft victims reported having difficulty obtaining or using a credit card, 10% reported being refused a cheque account or having cheques rejected. The survey reflects that a total of 37% of all ID theft victims reported having at least one of the aforementioned problems and that 21% of victims reported having more than one of these problems. In addition, 33% of victims who had experienced one or more of these problems said that they had spent 40 hours or more resolving problems related to their ID theft. Similarly, CIFAS reports that, victims may need between 3 and 48 hours of work to sort through problems and clear their name. CIFAS adds that "in cases where a "total hijack" has occurred, perhaps involving 20-30 different organisations, it may take the victim over 200 hours and cost up to GBP 8 000 before things are back to normal."<sup>49</sup>

Moreover, law enforcement authorities report that consumers victimised by ID theft may lose out on job opportunities; be denied loans for education, housing, or cars as a result of negative information on their credit reports; or be arrested for crimes they did not commit. Victims also suffer indirect financial costs, including costs incurred in lawsuits initiated by creditors and in overcoming other obstacles they face in obtaining or retaining credit. In addition, they suffer the emotional toll of having their privacy violated and the frustration of attempting to restore their reputation and credit history.

#### Liability

ID theft can occur as a result of personal, business, or government negligence. It can also take place in instances where there is no apparent negligence from any party. How ID theft occurs has implications for liability. Businesses, for example, often due to inadequate security practices, may be exposed to the theft of sensitive consumer data they hold. As a consequence, they may bear both direct and indirect losses in the form of liability suits, fines, and loss of clientele.<sup>50</sup>

Both legislation and voluntary business practices deal with the issue of liability. As provided in the *1999 E-commerce Guidelines* (OECD, 1999, Section V), "[L]imitations of liability for unauthorised or fraudulent use of payments systems, and chargeback mechanisms offer powerful tools to enhance consumer confidence and their development and use should be encouraged in the context of electronic commerce." Likewise, in its 2007 *Resolution on ID theft, phishing and consumer confidence,* the Transatlantic Consumer Dialogue ("TACD") recommends "the assignment of the liability for financial damages caused by ID theft or phishing to the respective companies or service providers involved and not to consumers, unless they are proven to have acted negligently." <sup>51</sup> In most countries, business liability may

be based on a duty for companies to provide reasonable security for all confidential data held and/or on a duty to disclose security breaches involving sensitive personal information. Such a duty, whether of a tort or contractual nature, is an important remedy tool for consumers falling victims of ID theft.<sup>52</sup>

In many member countries, legislation provides for ceilings of liability for the cost of fraudulent transactions by identity thieves.<sup>53</sup> In the United States, for example, consumer liability is limited to a maximum of USD 50 for unauthorised credit card charges; <sup>54</sup> for unauthorised electronic fund transfers, such liability is also limited, depending upon the timing of consumer notice to the applicable financial institution.<sup>55</sup> In the European Union, various instruments aim at protecting consumers from unauthorised payments. Under the 1997 European Commission's Recommendation on *transactions by electronic payment instruments and in particular the relationship between issuer and holder*,<sup>56</sup> consumers should bear the loss of unauthorised transactions up to a maximum of EUR 150, provided that they have not acted with extreme negligence. Under Directive 2002/65/EC *concerning the distance marketing of consumer financial services*,<sup>57</sup> consumers should be allowed to request cancellation of a payment where fraudulent use has been made of their payment card in connection with distance contracts, and in the event of such fraudulent use, to be re-credited with the sum paid or have it returned.<sup>58</sup> In the United Kingdom,<sup>59</sup> under the Banking Code, "[I]f someone else uses [someone's] card details without ... permission for a transaction where the cardholder does not need to be present, [the cardholder] will not have to pay anything." In some countries, in addition to laws and regulations, industry practices provide consumers with "zero liability.<sup>560</sup>

# **C.** Are there more victims off line than on line?<sup>61</sup>

In many instances, data does not clearly separate online ID theft cases from those occurring off line, making it difficult to assess which of the two activities is more prevalent. Whether ID theft is more dangerous on-line than off line is actually a controversial issue.

#### Is ID theft more prevalent off line?

According to a 2006 survey by Javelin Strategy and Research ID theft is more prevalent off line than on line (JSR, 2006). Only 10% of US identity fraud cases occurred when the victim was on-line, against 63% when the victim used more traditional channels. The report states that more than 90% of identity fraud starts off conventionally by means of stolen bank statements, misplaced passwords, or bills stolen from the victim's mailbox. It concludes that if it is true that more attempts of ID theft are made on line, in only one out of 10 of those incidents did the actual successful theft of the personal data take place on the Internet. It goes on saying that this relatively low level of successful attacks is explained by the fact that a majority of leading US financial institutions have introduced adequate measures to detect and protect their customers against ID theft on line.

The conclusions of this report are however debatable. They are going against the opinion that ID theft is today more serious on line than off line.

Indeed, others have recognised the severity of the problem and noted that ID theft has a direct impact on e-commerce transactions.

According to a 2006 International Telecommunication Union online survey (ITU, 2006), more than 40% of users would refrain from transacting on-line for fear that their personal information could be stolen.

#### D. Remediation tools available to victims

In the United States, an important part of the multi-faceted approach to combating ID theft is developing adequate remediation tools for victims. Several federal and state laws offer victims of ID theft options to avoid or mitigate the damages caused by ID theft. Consumers are encouraged to report incidences of ID theft to the US FTC, which generates a report that may be used by law enforcement agencies to facilitate the extension of a fraud alert or to block fraudulent trade lines on a credit report.<sup>62</sup>

US victims of ID theft can also request one of the three Credit Reporting Agencies (Experian, Equifax, or TransUnion) to place an "initial fraud alert" on their credit report for a period of not less than 90 days, which requires creditors to confirm the consumer's identity before opening new accounts or making changes to existing accounts.<sup>63</sup> If a victim has an ID theft report documenting actual misuse of the consumer information, he is entitled to place a seven-year alert on his file.<sup>64</sup> In addition, victims may request a free copy of their credit report.<sup>65</sup> If the credit report contains fraudulent information as a result of the theft, the consumer may ask that the information be blocked from the credit report.<sup>66</sup>

ID theft victims in the United States are also advised to obtain records and application information from financial institutions that handled transactions conducted by the ID thieves in the victim's name (US IDTTF, 2007, Vol. II, p. 75).<sup>67</sup> In addition, US law enforcement authorities advise victims to close fraudulently opened or compromised accounts and send a letter to debt collectors claiming a debt that the victim has not incurred (US IDTTF, 2007, Vol. II, p. 76). In some states, victims may request a "credit

freeze" preventing their credit reports from being released without their express consent (US IDTTF, 2007, Vol. I, p. 46).

In Australia, people can ask credit reporting agencies to place an alert on their file if they suspect they are the victim of identity theft. The Australian Standing Committee of Attorney's General 2007 *Discussion Paper on Model Identity Crime Offences*<sup>68</sup> also canvases the issue of assistance that may be needed for victims of ID theft.

#### SECTION V. ID THEFT LAW ENFORCEMENT SCHEMES

Today, numerous stakeholders including governments, business, industry and civil society, at both domestic and international levels, are combating the spread of cyber attacks. Various education tools have been deployed to alert users about ID theft. In some countries, different bodies have put in place coordinated domestic actions to investigate and prosecute ID theft. At the international level, numerous organisations, forums and networks, whether public or private, serve as platforms aiming at improving OECD member country enforcement initiatives. All these actions reflect how governments and the private sector actively combat online ID theft through legislation, development of industry best practices, consumer education, and targeted law enforcement initiatives.

However, the extent to which these initiatives are handled in a co-ordinated manner is challengeable. As seen in Section I of this paper, many economies do not have adequate or specific legislation prosecuting ID theft. Others, in turn, qualify this illicit activity as a crime. This difference in tackling the issue may impede consistent and effective implementation of member country co-ordinated actions to stem ID theft.

#### A. Domestic law enforcement schemes

Business and industry sometimes claim that individuals should be more aware of their responsibility to contribute to safeguarding their identities. However, individuals will not retain effective control over their personal data without strong education efforts. Internet users' awareness about ID theft should therefore be a key priority for governments, business and industry (OECD, 2006b, p. 74). Some studies have indeed shown that users do not yet fully realise the extent to which they can expose themselves to online threats.<sup>69</sup>

#### Public consumer and user education and awareness

Evidence from the 2006 EU Barometer suggests that consumer education, information and empowerment play a key role in raising consumer confidence and boosting cross-border transactions. Throughout the survey, it has been apparent that the more educated and informed consumers are, the more confident they feel in making cross-border purchases. Likewise, the 2003 Cross-border Fraud Guidelines recommend that member countries "educate consumers about fraudulent and deceptive commercial practices" (OECD, 2003, Section II. F). As regards ID theft, education should not be limited to consumers. All users (including all actors, whether public or private, who participate in the enforcement of anti-ID theft rules and practices) should be aware of the problem, how it occurs, who it affects and how it can be avoided or stopped.

Many countries have launched education and awareness campaigns targeting consumers - and more generally users - to alert them about the risks of becoming a victim of ID theft and to help them address the problem once it has occurred.

In February 2004 the Australian Government developed and released a national *Identity Theft Information Kit*, to provide the Australian community with information and strategies on how to prevent and respond to identity theft. The Australian Government also released a concise information booklet on identity theft in March 2007 as part of the Australasian Consumer Fraud Taskforces (ACFT) identity theft week, which operated as part of the ACFT's annual fraud awareness campaign.<sup>70</sup>

In the United Kingdom, the Home Office Identity Fraud Steering Committee launched the <u>www.identity-theft.org.uk</u> website which contains tips about how to avoid ID theft and where victims can find technical and legal help and support to clear out their misused identity. The website notably contains a link to the *GetSafeOnline* website which was created to support "*GetSafeOnline*," the first UK Internet security awareness campaign launched in 2005.<sup>71</sup> A 2006 *GetSafeOnline* report revealed the first positive results of the campaign. According to a market research launched in October 2005, 62% of people had identified and understood the campaign messages, resulting in 30% keeping their personal details safe. However, the report points out remaining challenges showing a "knowledge security gap" since 40% of people remain unsure of where to go to get advice on how to stay safe online (*GetSafeOnline*, 2006, p. 10). The UK Department of Trade and Industry ("DTI") has likewise developed "*Consumer Direct*," a telephone and Internet advice service providing consumers with information on fraud and notably on phishing.<sup>72</sup>

In Mexico, the public University of Mexico ("UNAM") has put in place various websites to alert consumers and users about all sorts of security risks on line. Advice on the identification of scams (www.seguridad.unam.mx/doc?ap=articulo&id=121), pharming (www.seguridad.unam.mx/usuario-casero/pharming.dsc), phishing (www.seguridad.unam.mx/usuario-casero/phishing.dsc.) and tips to prevent privacy (www.seguridad.unam.mx/doc?ap=articulo&id=118) and security breaches are provided to users.

In Canada, PhoneBusters National Call Centre ("PNCC"),<sup>73</sup> the country's anti-fraud call centre operated by the Royal Canadian Mounted Police and the Ontario Provincial Police, educates consumers on fraud scams through its nationwide awareness campaign "*Recognise It. Report It. Stop It.*" The campaign includes tips on how to avoid falling victim to identity theft and where to report it.

In February 2005, the US FTC organised, in co-operation with federal, state and local agencies, and national advocacy organisations, the National Consumer Protection Week ("NCPW"), during which it educated consumers about the theme of "Identity Theft: When Fact Becomes Fiction." The 2005 NCPW focused on minimising the risk of ID theft and taking fast action in the event it occurs. The FTC also launched the NCPW website, <u>www.consumer.gov/ncpw</u>, which contains information for consumers and businesses including phishing. On 10 May 2006, the FTC launched another nationwide campaign to educate consumers about ID theft.<sup>74</sup> Starting from the premise that there is no guarantee that ID theft can be avoided, the "*Deter, Detect, Defend*" campaign aims at helping consumers take steps to minimise the

risks and damages if the problem occurs.<sup>75</sup> The campaign is conducted through the distribution of brochures, kits,<sup>76</sup> and a warning video.<sup>77</sup>

The US Department of Justice ("US DOJ") is also active in educating consumers about ID theft and has produced radio and television public service announcements about ID theft (US IDTTF, 2007, Vol. II, p. 30-31). The Federal Deposit Insurance Corporation ("FDIC") has also prepared educational tools and is working on an educational campaign, scheduled for rollout in 2007, to educate consumers about online banking and the protections available to them that make it safe. The US Social Security Administration, the US Postal Inspection Service ("USPIS"), the US Department of Education, the US Department of Health and Human Services, and the US Securities and Exchange Commission ("SEC") have also published guidance to consumers on ID theft.

In some other OECD countries however, public information on how to avoid being caught by cyber fraudsters, where to report and file a complaint is not always available.

### **Empowering domestic enforcement bodies**

#### Enhanced domestic co-ordination

In the United Kingdom, the Government has established the Identity Fraud Steering Committee, which includes representatives of a wide range of public agencies, law enforcement and the private sector. It benefits from CIFAS, a private organisation run by the financial sector which receives reports of attempted or completed frauds against the financial sector. Together with UK credit reference agencies, CIFAS assists the financial sector in verifying the identity of individuals applying for financial services, and informs industry whether that individual has been linked to previous frauds.

In the United States, various Federal authorities are empowered to investigate and prosecute ID thieves. The US DOJ and federal prosecutors work together with federal investigative agencies such as the Federal Bureau of Investigation ("FBI"), the US Secret Service, and the United States Postal Inspection Service to prosecute ID theft and fraud cases. These agencies have launched special enforcement initiatives to combat ID theft. For example, the FBI Cyber Division also conducted *Operation Spam Slam*, a criminal spam and malicious code investigative initiative supported daily by more than 20 small and medium-sized enterprises. The private sector also provided additional support for the project, which has resulted in more than 100 investigations (US IDTTF, 2007, Vol. II, p. 50-51).

US state criminal law enforcement efforts are also critical to the fight against ID theft. All 50 states and the District of Columbia have some form of legislation that prohibits ID theft. According to a 2005 National Survey of State Court Prosecutors (US IDTTF, 2007, Vol. II, p. 45), 69% of all prosecutors surveyed, and 97% of prosecutors surveyed from areas with populations of 1 million or more, had litigated at least one computer-related ID theft case.<sup>78</sup> In addition, 80% of all prosecutors surveyed, and 91% of prosecutors surveyed from areas with populations of a computer-related credit-card fraud case.

A number of US federal and state law enforcement authorities have formed multi-agency task forces or working groups to facilitate the prosecution of ID theft laws. US federal authorities, including the US Attorney's Offices, FBI, Secret Service, and USPIS, lead or co-lead more than 90 task forces and working groups devoted (in whole or in part) to ID theft.

In May 2006, the US Office of Community Oriented Policing Services ("COPS") presented its national strategy to stem ID theft through several recommendations including the creation of state-level co-ordination centres providing crime analysis, victim assistance, state-wide investigations and law enhanced enforcement co-operation.

In addition, on 10 May 2006, the US Identity Theft Task Force, comprised of 17 federal agencies and co-chaired by Attorney General Alberto R. Gonzales and Federal Trade Commission Chairman Deborah Platt Majoras, was created.<sup>79</sup> The Task Force aims at developing a nationwide strategic plan to better prevent ID theft, co-ordinate prosecution, and ensure recovery for the victims. One of the main goals of the Task Force is to promote enhanced co-operation by Federal departments and agencies with state and local authorities responsible for the prevention, investigation, and prosecution of ID theft, to notably avoid unnecessary duplication of effort and expenditure of resources. In January 2007, the Task Force launched a public consultation (US FTC, 2007a) to receive comments on its Interim Recommendations (US FTC, 2006) on ways to improve the effectiveness and efficiency of federal government efforts to reduce ID theft.

On 23 April 2007, the Task Force issued a report that sets forth a strategic plan for addressing myriad challenges presented by ID theft. The strategic plan focuses on four key areas: "(1) keeping sensitive consumer data out of the hands of identity thieves through better data security and more accessible education; (2) making it more difficult for identity thieves who obtain consumer data to use it to steal identities; (3) assisting the victims of identity theft in recovering from the crime; and (4) deterring identity theft by more aggressive prosecution and punishment of those who commit the crime." (US IDTTF, 2007, Vol. I, p. 4). The Task Force made a number of recommendations in each of these four areas, including reducing unnecessary use of Social Security Numbers, establishing national standards for private sector entities to safeguard the personal data they collect and to provide notice to consumers when a breach occurs that poses a significant risk of ID theft, implementing sustained consumer awareness campaigns, and establishing a National Identity Theft Law Enforcement Center to enhance law enforcement co-operation in prosecuting ID thieves.

The public and the private sectors have collaborated to improve information sharing on ID theft. For example, the US Secret Service hosts a portal called the e-Information system for members of the law enforcement and banking communities (US IDTTF, 2007, Vol. II, p. 57). The e-Information system provides a forum for members to post the latest information on scams, counterfeit cheques, frauds and swindles, and updates Bank Identification Numbers. The USPIS created the Intelligence Sharing Initiative website in 2005, which allows fraud investigators representing retail and financial institutions to share information pertaining to mail theft, ID theft, financial crimes, investigations, and prevention methods. The website also gives users access to the "Hot Addresses List"-- a list of addresses located throughout the United States and Canada linked to a variety of fraud schemes, including fraudulent applications schemes, account takeover schemes, mail order schemes, and reshipping schemes (US IDTTF, 2007, Vol. II, p. 58).

In Japan, the Council of Antiphishing Japan,<sup>80</sup> a private forum composed of 22 companies and 3 associations, collects data and trends about phishing scams and provides technical and legal advice on

how to stem ID theft. Japan's Ministry for Economy, Trade and Industry ("METI"), Ministry of Internal Affairs and Communications ("MIC") and the National Police Agency ("NPA") hold a status of observer in the Council's activities. In addition, MIC hosts meetings of the "Contact Group to Promote Countermeasures Against Phishing" with related businesses and government offices to share information between ISPs and to search for effective countermeasures. METI and NPA hold the status of observer in the Contact Group's activities.

# Resources and training

Many member country enforcement authorities often lag behind cyber fraudsters to keep up-to-date with technology advances and the methods to protect them. These actors should receive appropriate technical education to ensure that they are aware of how thieves operate. Such education should be done through regular training to ensure that authorities are kept up-to-date with the rapid evolution of ID theft techniques. More resources should be devoted in this respect (NCL, 2006; UN CC IEGFCMFI, 2007).

The US ID Theft Task Force has recommended that US federal agencies assist, train and support foreign law enforcement through the use of Internet intelligence-collection entities, including the Internet Crime Complaint Center and the Cyber Initiative Resource Fusion Center, as well as engage in joint investigations (US IDTTF, 2007, Vol. I, p. 62). On the national level, US Attorney's Offices participate in ongoing training seminars, and several law enforcement agencies - including the US DOJ, USPIS, the US Secret Service, the US FTC, and the FBI — along with the American Association of Motor Vehicle Administrators, have jointly sponsored over 20 regional, one-day training seminars on ID theft for state and local law enforcement agencies across the country (US IDTTF, 2007, Vol. II, p. 71-73). Several other agencies actively co-ordinate training programmes. Notably, the US Secret Service has developed a training video on ID theft for police departments, and its Electronic Crimes Section has trained over 150 state and local officers from across the United States to conduct computer investigations and computer forensic analysis (US IDTTF, 2007, Vol. II, p. 72). The National White Collar Crime Center ("NW3C"), a non-profit organisation that provides training programmes and other assistance to state and local law enforcement authorities in partnership with the Bureau of Justice Assistance, has developed a three-day ID theft course. The curriculum includes topics such as tools, techniques, and resources for investigating ID theft crimes, and the basics of ID theft for financial gain.

### Data security breaches disclosure

In the United States, the *Gramm-Leach-Bliley Act* ("GLB Act") introduced mandatory protection of consumers' personal financial information by financial institutions.<sup>81</sup> The GLB Act addresses two distinct types of protection for personal information: security and privacy. The security provisions require the agencies to write standards for financial institutions regarding appropriate physical, technical, and procedural safeguards to ensure the security and confidentiality of customer records and information, and to protect against anticipated threats and unauthorised access to such information.<sup>82</sup> The privacy provisions

require financial institutions to notify their customers of their information-sharing practices and provide customers with an opportunity to opt out of information-sharing with certain unaffiliated third parties in certain circumstances.<sup>83</sup> Various federal agencies, including the federal bank regulatory agencies, the FTC, and the Securities and Exchange Commission ("SEC"), have issued regulations or guidelines addressing both the security and privacy provisions of the GLB Act.<sup>84</sup>

The US states have also recognised the importance of breach notification. In 2003, California passed two significant data security breach laws.<sup>85</sup> Likewise, 37 US states have laws that impose a duty on companies to disclose security breaches affecting sensitive personal information of their customers, and some laws have safeguard and disposal requirements (US IDTTF, 2007, Vol. I, p. 34). The states have taken a variety of approaches regarding when notice to consumers is required. Some states require notice to consumers whenever there is unauthorised access to sensitive data. Other states require notification only when the breach poses a risk to consumers, and do not require notice when the data cannot be used to commit ID theft, or when technological protections prevent access to the data. A number of bills have been introduced in the US Congress that would establish a federal notice requirement.

In 2005 and 2006, the US FTC brought 14 enforcement actions against companies for failure to provide reasonable data security (US IDTTF, 2007, p. 11). Its action against ChoicePoint, a US-based company compiling and selling consumers' personal information to more than 50 000 businesses, was largely covered in the press. In 2005, ChoicePoint recognised that it had sold information about more than 163 000 consumers to people who turned out to be ID thieves. On that basis, the US FTC charged the company for violating the US Fair Credit Reporting Act by furnishing consumer reports to subscribers who did not have permission to obtain them, and by failing to maintain reasonable procedures to verify both their identities and how they intended to use the information. The company agreed to reimburse the victims of ID theft and committed to: implement new procedures to ensure that only legitimate businesses would be provided with consumer reports; establish and maintain a comprehensive information security program; and obtain audits by an independent third-party security professional every other year until 2026.<sup>86</sup>

Most companies are reluctant to disclose data security breaches, fearing a negative impact on their business. The 20% decline that ChoicePoint incurred in its stock prices following its 2005 disclosure illustrates this risk.

In Japan, data breach notification is considered in the context of the Japanese Act on the Protection of Personal Information, which went into effect in 2005. More specifically, the Cabinet Office of Japan has

issued a "Basic Policy on the Protection of Personal Information"<sup>87</sup> stating that, in the case of leakage of personal information, it is important that the concerned entity make public the fact of the case to the extent possible, in order to prevent secondary damage and avoid occurrence of similar cases. Under the Guidelines issued by the Financial Services Agency, financial institutions are under the duty to report any data leak to the authorities.

In Australia, the National Privacy Principles ("NPPs") and Information Privacy Principles ("IPPs") in the *Privacy Act 1988 (Cth)* impose privacy obligations on government agencies and private organisations in relation to the handling of personal information. In particular, NPP's and IPP's require that agencies and organisations must take reasonable steps to protect the personal information they hold from misuse and loss and from unauthorised access, modification or disclosure. Agencies and organisations must therefore ensure that they have appropriate security requirements in place to ensure that breaches do not occur and must be accountable for when breaches occur.

In the context of its current review of privacy laws, the Australian Law Reform Commission ("ALRC") is considering the issue of whether Australia should introduce requirements in the *Privacy Act 1988 (Cth)* to require organisations and agencies to notify individuals of data breaches. On 12 September 2007, the ALRC released *Discussion Paper 72: Review of Australian Privacy Law*, which outlines draft proposals for reform. The ALRC is due to provide a final report to Government by the end of March 2008.

There is currently no data breach disclosure obligation in EU Member States. Article 4 of the 2002 Directive on the Processing of Personal Data and the Protection of Privacy in the Electronic Communications Sector ("the e-Privacy Directive")<sup>88</sup> requires ISPs to notify their subscribers about security risks, without however imposing on them to notify actual security breaches. Under the European Commission's proposed reform of the regulatory framework for electronic communications,<sup>89</sup> ISPs would be required to notify both the national regulatory authorities and their customers of any breach of security that led to the loss of personal data and/or to interruptions in the continuity of service supply and their customers of any breach of security leading to the loss, modification or destruction of, or unauthorised access to, personal customer data. The proposal has been welcomed by the Article 29 Data Protection Working Party.<sup>90</sup> In its comments on the proposal in December 2006, the US FTC invited the European Commission to carefully consider whether it should require service providers to notify customers of security breaches under all circumstances. The US FTC rather suggested that consumers should be notified in the event of a security breach creating a significant risk of identity theft or other related harm.<sup>91</sup>

#### What role for industry, business, and ISPs?

According to a *Global Security Survey* conducted by Deloitte Touche Tohmatsu in 2006, 53% of responding financial institutions considered that phishing and pharming would be the most significant threat over the next twelve months, followed by 51% of respondents by viruses and spyware. Only 30% of them declared that they had implemented technological tools to prevent these types of attacks (DTT, 2006, p. 13). However, in its 2006 Global information Security Study, PricewaterhouseCoopers indicates that an increasing number of executives across all industries are taking the threat more and seriously and made incremental improvements in deploying security policies and technologies, as reflected by doubled security budgets (PwC, 2006).

ISPs have also deployed a range of initiatives to help customers protect their security on line. Many provide software to protect against viruses and spyware, as well as filter e-mails for spam and viruses before they reach the users to minimise the risk of malware being installed on machines. BT, in conjunction with Yahoo!, filters its customers' mailboxes to help prevent spam from reaching their inboxes. Mail providers like Yahoo! Mail, are also developing technologies, such as DomainKeys, offering a cryptography-based solution to help solve the problems of phishing and email forgery, as they validate the origin of e-mail messages. ISPs also follow many of the guidelines of the Anti-Phishing Working Group ("APWG") on how to prevent and mitigate the damage caused by phishing attacks. ISPs have finally joined software providers and government bodies into technical bodies such as the Messaging Anti-Abuse Working Group to ensure that Internet users are safer on line.

In the United States, the payment card segment of the financial services industry has adopted one set of data security standards, the Payment Card Industry Security Standards ("PCI Standards"), for all merchants and service providers that store, process, or transmit cardholder data. The PCI Standards are designed to ensure that merchants and service providers properly handle and protect cardholder account and transaction information. Visa has its own program, the Cardholder Information Security Program, to ensure date security compliance in accordance with PCI Standards.<sup>92</sup>

In the event of a data breach, organisations such as the American Bankers Association, the Financial Services Roundtable, and the Payment Card Industry have developed guidelines to address breach response issues. They encourage businesses to create an internal response plan that, among other things, confirms, analyses, and documents events and, in the event of a breach, they advise entities to immediately contain the breach and limit possible exposure of consumer information while preserving logs and other electronic evidence.<sup>93</sup>

Organisations such as the Council of Better Business Bureaus and the National Cyber Security Alliance have produced primers for small business on information including: the importance of employee screening and training in the use of physical safeguards beyond electronic measures to prevent identity theft, tips for recognizing attempts at ID theft, and guidance on the handling and management of sensitive information.

Other businesses have adopted industry and government guidelines on how to detect and avoid malware, including guidelines developed by the US National Institute of Standards and Technology ("NIST") (US IDTTF, 2007, Vol. II, 25). NIST's recommendations for improving an organisation's malware incident prevention measures include: planning and implementing an approach based on the most likely point of attack, ensuring that policies address the prevention of malware incidents and include provisions relating to remote workers, and using appropriate techniques to prevent malware incidents

(*e.g.* patch management, application of security configuration guides). In addition, some private sector entities have developed standards and guidelines to ensure that third party service providers, such as outsourced IT operations, adhere to the contracting parties' security requirements.

Despite the substantial effort undertaken by public and private sector entities on how to respond to data breaches, surveys of large corporations and retailers in the US indicate that fewer than half of them have formal breach response plans (US IDTTF, 2007, Vol. I, p. 35). For example, an April 2006 cross-industry survey showed that only 45% of large multinational corporations headquartered in the United States had a formal process for handling security violations and data breaches. Fourteen percent of the companies surveyed had experienced a significant privacy breach in the past three years. A July 2005 survey of large North American corporations found that although 80% of responding companies reported having privacy or data protection strategies, only 31% had a formal breach notification procedure. Moreover, one survey found that only 43% of retailers had formal incident response plans, and an even smaller percentage of retailers had actually tested their plans.

In Mexico, the eCrime working group formed by public and private entities including the Mexican Banks Association ("ABM"), the Industry Transformation National Chamber ("Canacintra"), the National Bank of Mexico ("Banamex"), the Bancomer Bank, the Mexican Internet Association ("AMIPCI"), the Preventive Federal Police, Federal Communications Commission ("COFETEL"), the National Bank and Values Commission ("CNBV"), Nic Mexico and the public University of Mexico ("UNAM"), was created to gather data on phishing trends and to cancel domain names associated with identity fraud.

### Private sector consumer education tools

Financial institutions, which can be primary victims in a phishing attack, increasingly alert their customers about new phishing messages and security risks. In the United States, since 2004, financial institutions have undertaken joint educational efforts through the ITAC, a domestic organisation representing some of the largest US banks, brokerages, and finance companies.<sup>94</sup> In addition, the NASD issued an alert entitled "Phishing and Other Online Identity Theft Scams: Don't Take the Bait" (US IDTTF, 2007, Vol. II, p. 40).

The National Cyber Security Alliance maintains *Stay Safe Online*, a website with safe computing tips such as how to stop suspect e-mails and websites.<sup>95</sup> Similar outreach efforts have been made by other private organisations. For example, Microsoft and Best Buy, in conjunction with other private and public partners, sponsor the Get Net Safe Tour which sends experts to schools, Internet fairs, and community centers to discuss Internet safety (US IDTTF, 2007, Vol. II, p. 39).

Many US colleges and universities have also tried to increase awareness of ID theft among vulnerable college students through websites, orientation campaigns, and seminars. The National Council of Higher Education Loan Programs (NCHELP) reached out to its constituents and encouraged them to take advantage of the US FTC's resources on preventing ID theft and share them with students (US IDTTF, 2007, Vol. II, p. 42).

In the United Kingdom, various banking and payment associations such as the Financial Services Authority ("FSA"), the British Banker Association ("BBA"), and the UK payments Association ("APACS"),<sup>96</sup> have pro-actively developed initiatives to educate both their own members (*i.e.* banks, and

companies) and their customers (OFCOM, 2006, p.37). Even in countries where ID theft is not yet perceived as a serious threat, financial institutions alert their customers about how to keep safe on line. In the Netherlands for example, *Nederlands Vereniging van Banken* ("NVB"), the Dutch Banking Association, began an awareness campaign in 2006 informing consumers about the risks of ID theft and how to better protect their personal information (INTERVICT, 2006, p. 24).

In Mexico, some members of the Internet Mexican Association ("AMIPCI") have created a website <u>www.navegaprotegido.com.mx</u>, which contains information aimed at educating consumers on the risks of ID theft.

Some security vendors have also put in place alert systems to inform their customers about online risks. For instance, under its *Security Connection* service, Symantec, in conjunction with financial institutions, provides customers of these financial institutions with tools to make them aware about ongoing online threats and to enable them to recognise, avoid, and denounce them. Typically, customers accessing financial institutions' websites are routed to Symantec *Security Connection* where articles, expert advice, and real time security alerts are available.

In addition, ISPs have developed educational initiatives around the risks and precautions users should take when operating on line. For instance, the UK Yahoo!'s Security Centre provides information on the latest virus alerts as well as tips on how users can stay safe on line.

# Legal right of action

Few countries provide ISPs with a right of action, on behalf of their customers, against perpetrators of "phishing" attacks.<sup>97</sup> In most countries, in a successful phishing scam, only the affected Internet user is entitled to take legal action against the phisher, to the exclusion of ISPs or the spoofed company. In France for example, when the law on the digital economy was debated in the French Parliament, the national Association of Internet Service Providers (*Association des Fournisseurs d'Accès et de Services Internet* (« AFA »))<sup>98</sup> proposed that such a right of action be extended to ISPs on behalf of their customers. This proposal was going in the same direction as one recommended measure in the *OECD 2006 Anti-Spam Toolkit* which provides that "ISPs should be able to take appropriate and balanced defensive measures to protect their networks, and should be allowed to take legal action against spammers" (OECD, 2006c, p. 12). Although AFA's proposal was eventually rejected by the French Parliament, the Association continues to request French authorities to consider it.

Noting that in a typical phishing scam each victim may not sustain losses significant enough, or have the resources to pursue enforcement action individually, Microsoft has recently re-advocated that ISPs and aggrieved businesses should be allowed, in the EU, to take legal action against cybercriminals (Microsoft, 2006) to protect their customers and recoup their own significant losses by bringing damage claims for the costs they incur from cybercrime, including reputation and consequential damages.

# B. International, bilateral and regional law enforcement co-operation frameworks

### International law enforcement systems

Various international forums including international organisations and informal networks focusing on security, privacy or consumer protection issues, devote substantive efforts to tackle cybercrime's multiple facets.

### International organisations

• OECD

The OECD has been involved with efforts to build user trust on line through more effective crossborder law enforcement. It has analysed the challenges and developed policy responses in the areas of fraud against consumers, spam, security and privacy, through the following main instruments:

- *E-commerce Guidelines* (OECD, 1999): these *Guidelines* reflect existing legal protection available to consumers in more traditional forms of commerce; encourage private sector initiatives that include participation by consumer representatives; and emphasise the need for co-operation among governments, businesses and consumers. Their aim is to encourage: fair business, advertising and marketing practices; clear information about an online business' identity, the goods or services it offers and the terms and conditions of any transaction; a transparent process for the confirmation of transactions; secure payment mechanisms; fair, timely and affordable dispute resolution and redress; privacy protection; and consumer and business education.
- Cross-border Fraud Guidelines (OECD, 2003): these Guidelines establish a common framework to combat online and offline cross-border fraud through closer, faster, and more efficient co-operation between consumer protection enforcement agencies. As concluded in the OECD report on the implementation of the Guidelines, (OECD, 2006c), within three years, OECD member country domestic and international co-operation systems have been improved through: strengthened enforcement agencies; enhanced national co-ordination between government bodies and with the private sector; intensive consumer education about the challenges of cross-border fraud; and the exchange of information and best practices at the international level.
- *Recommendation on Consumer Dispute Resolution and Redress* (OECD, 2007a): the Recommendation addresses the current practical and legal obstacles to pursuing remedies in consumer cases, whether locally or in a cross-border context.
- Security Guidelines of Information Systems and Networks (OECD, 2002): these Guidelines provide a framework of principles to foster consistent domestic approaches in addressing security risks in a globally interconnected society. Following their release, the OECD monitored efforts by governments to implement national policy frameworks, including protecting critical information infrastructures, combating cybercrime, developing Computer Security Incident Response Teams, raising awareness, and fostering education (OECD, 2007d). In 2006, the OECD issued a *Guidance on Electronic Authentication* setting out a number of operational principles aimed at helping member countries establishing or modernising their approaches to authentication. This guidance was followed in 2007 by the adoption of an *OECD Recommendation on Electronic Authentication* (OECD, 2007c), encouraging member countries

to establish compatible, technology-neutral approaches for effective domestic and cross-border electronic authentication of persons and entities.

- Guidelines on the Protection of Privacy and Transborder Flows of Personal Data (OECD, 1980): these Guidelines set out core principles aimed at assisting governments, business and consumer representatives in their efforts to protect privacy and personal data, and in obviating unnecessary restrictions to transborder data flows, both on and off-line. In October 2006, the OECD published a report describing member country current attempts to address privacy challenges. Despite these efforts, the report highlights the need for a more global and systematic approach to cross-border privacy law enforcement co-operation (OECD, 2006a). Responding to this conclusion, in 2007, the OECD adopted a Recommendation on Cross-border Co-operation in the Enforcement of Laws Protecting Privacy (OECD, 2007b), which sets out principles aimed at enabling member country authorities to co-operate with foreign authorities, as well as to provide mutual assistance to one another in the enforcement of privacy laws.
- Anti-Spam Toolkit (OECD, 2006b): Aimed at facilitating international co-operation in the fight against spam, the toolkit is based on the premise that various elements need to be brought together to bear on the problem of spam and help develop anti-spam strategies and solutions in the technical, regulatory and enforcement fields. It provides a set of recommendations aimed at establishing consistent and complementary policies and other (*e.g.* enforcement) anti-spam initiatives among OECD member countries.

The OECD also co-operates with other international forums to ensure effective cross-border cooperation. The Asia-Pacific Economic Co-operation ("APEC")<sup>99</sup> and the OECD have joined forces to provide policy makers in their economies with a global picture of the malware phenomenon. This collaboration is undertaken under a joint project conducted with the help of an "APEC-OECD group of experts," composed of delegates to both groups, representatives of Computer Emergency Response Teams ("CERTs"),<sup>100</sup> and enforcement bodies. In March 2007, the OECD and APEC held a workshop on malware. As mentioned earlier,<sup>101</sup> this event informed a joint analytical report aimed at helping governments identify priority areas of intervention and provide policy orientation to develop appropriate strategies to combat the proliferation of malware (OECD, 2008).

APEC member economies have undertaken specific strategies to establish regulatory frameworks providing the essential underpinnings for growth and consumer confidence in the digital marketplace. In 2002, APEC endorsed its *Cyber Security Strategy* recommending its member economies to adopt legislation and policies criminalising cybercrime. In 2005, it further urged its members to address the threat posed by the misuse, malicious and criminal use of the online environment under its *Strategy to Ensure a Trusted, Secure and Sustainable Online Environment* (APEC, 2005).

The International Telecommunication Union ("ITU") and the Asia-Europe meeting ("ASEM")<sup>102</sup> are other platforms where policy makers and law enforcers around the globe explore and recommend policy actions that could be adopted to improve international co-operation against cyber attacks.

• The United Nations

In 2005, an open-ended Intergovernmental Expert Group To Prepare a Study on Fraud and the Criminal Misuse and Falsification of Identity ("UN IEG") was set up to address the problem of fraud and criminal misuse of identity. In 2007, it issued a report containing the results of a 2005-2006 study,<sup>103</sup> commissioned by the United Nations Office on Drugs and Crimes ("UNODC"), on fraud and the criminal misuse and falsification of identity. The report, which integrates comments from notably the UNODC and the United Nations Commission on International Trade Law ("UNCITRAL"), contains a number of recommendations for best practices to be implemented by governments and the private sector (UN IEG, 2007, pp. 5-20 and see Annex I to this report).

As recommended in the UN Commission on Crime Prevention and Criminal Justice's 2007 *Resolution on International Co-operation in the Prevention, Investigation, Prosecution and Punishment of Economic Fraud and Identity-related Crime*, the UNODC set up a consultative platform of experts from governments, international organisations (including the OECD), and the private-sector, to pool experience and develop strategies on identity-related crime. The first meeting of the expert group was held in Italy in November 2007, in conjunction with an International Conference on identity-related crime.<sup>104</sup> The UNODC will build on the conclusions of both the expert group meeting and the International Conference to develop guidelines, best practices and training materials in the prevention, investigation and prosecution of identity-related crime.

• Interpol

Interpol is the international police organisation whose mission is to prevent or combat international crime.<sup>105</sup> Interpol frequently serves as the basis of co-operation between national police forces in conducting multinational investigations of online crime. Interpol has decentralised its cyber crime expert teams around the world through the establishment of regional Working Parties on Information Technology Crime for Europe, Latin America, Asia, South Pacific and Africa.<sup>106</sup> Interpol's European Working Party on Information Technology Crime ("EWPITC") has, for example, compiled a best practise guide for

experienced investigators from law enforcement agencies.<sup>107</sup> It has also set up a rapid information exchange system under an international 24-hour response scheme, listing responsible experts within more than 100 countries. This scheme was notably endorsed by the G8 24/7 High Tech Crime Network ("G8 24/7 HTCN"). The EWPITC further agreed to conduct a project aimed at enabling law enforcement agencies worldwide to investigate botnets and malicious code. This work will facilitate an operational co-operation project of European BotNet investigators to share intelligence and best practices.

## International informal networks

Policy frameworks are complemented by informal international networks of enforcement agencies fighting against fraud and spam.

• International Consumer Protection Enforcement Network ("ICPEN")

ICPEN is an informal network where domestic enforcement authorities join forces to enhance international consumer protection enforcement. It includes authorities from 36 countries plus two observers (the OECD, and the European Commission). ICPEN is mainly used as a platform of collaboration where member country enforcement bodies exchange information on fraud cases affecting consumers from their jurisdiction through monthly teleconferences, national reports, and the *econsumer.gov* website.

• London Action Plan ("LAP")

The LAP is a global co-operation network of governments and private sector representatives from around the world focused on combating spam and increasing international anti-spam co-operation. The plan was developed by the US FTC and the UK OFT in 2004 to curb the activities of international spammers, and now includes participants from more than 20 countries, including more than 30 government agencies and 20 private sector representatives. Key elements of the LAP include designating a point of contact for further enforcement communications, exchanging effective investigative techniques and enforcement strategies, and discussing consumer/business education. In November 2006, in conjunction with the Contact Network of Spam Enforcement Authorities ("CNSA"),<sup>108</sup> the LAP held a joint workshop on international enforcement co-operation against spam, spyware and other online threats. In October 2007, the LAP held another joint meeting with the CNSA that also featured joint sessions with the Messaging Anti-Abuse Working Group ("MAAWG").

• G8 24/7 High Tech Crime Network ("HTCN")

The G8 24/7 HTCN is another informal network which provides around the clock high-tech expert contact points<sup>109</sup> which permits the sharing of information on ongoing investigations against cyber criminals. Created in 1997, the G8 24/7 HTCN, which includes 45 countries, has, among other achievements, been used on several occasions to avert hacking attacks, including attacks on banks in the United States, Germany and Mexico.<sup>110</sup> In its report on fraud and the criminal misuse and falsification of identity,<sup>111</sup> the

UN IEG recommends that Member States make use of the G8 24/7 HTCN, both for emergency and nonemergency cases involving electronic fraud or identity-related crimes (UN IEG, 2007, paragraph 27, *d*).

# Bilateral and regional law enforcement frameworks

# Bilateral schemes

• Canada - United States Cross-Border Crime Forum<sup>112</sup>

This bi-national working group provides governments of the two countries with reports and recommendations laying the groundwork for substantial improvements in enforcement capabilities, binational co-ordination and co-operation in combating trans-national fraud. The working group is expected to assist the US Identity Theft Task Force to co-ordinate education, prevention and enforcement in relation to phishing, and ID theft. In October 2006, the Forum's Working Group on Cross-Border Mass-Marketing Fraud published a report on phishing and its impact on cross-border crime (BWGCBMMF, 2006). The report refers to several enforcement actions between Canadian and US authorities against phishers.

• Australasian Consumer Fraud Task Force ("ACFTF")

The ACFTF<sup>113</sup> is a group of 18 government regulatory agencies and departments from Australia and New Zealand responsible for consumer protection regarding frauds and scams. The Task Force runs the Consumer Awareness Month ("CAM"), a campaign educating consumers about scams. During the March 2006 CAM, the ACFTF focused on phishing scams, noting the lack of awareness among Australians who seem to be responding to these scams at a much higher rate than other countries.<sup>114</sup>

• The Police Commissioners' Conference Australasian Identity Crime Working Party

To implement the Australasian Identity Crime Policing Strategy 2003-2005, a Police Commissioners' Conference Australasian Identity Crime Working Party was established where police representatives from all Australian jurisdictions and New Zealand, the Australian Crime Commission, and the Australasian Centre for Policing Research develop a work plan to improve their fight against identity crime. Under its 2006-2008 Strategy (ASWPRPCC, 2005), the Working Party recommended the development of measures including: the allocation of appropriate resources by law enforcement to combat identity crime including; the provision of appropriate training to allow the implementation of best practice policing techniques in all jurisdictions; effective partnerships between local, Australasian, regional and international law enforcement authorities and with policing and public and private sector organisations.

## **Regional Schemes**

• The Council of Europe Convention on Cybercrime<sup>115</sup>

The Convention is the first and only legally binding multilateral treaty addressing the problems posed by the spread of criminal activity on line. Signed in Budapest in 2001, the Convention entered into force on 1 July 2004. Taking account of digitalisation, convergence and continuing globalisation of computer networks, the Convention requires its Parties to establish laws which criminalise security breaches resulting from hacking, illegal data interception, and system interferences that compromise network integrity and availability.

This instrument, whose Preamble notably cites OECD actions as a means to further advance international understanding and co-operation in combating cybercrime, aims at "pursuing ... a common criminal policy for the protection of society against cybercrime by adopting appropriate legislation and fostering international co-operation." To achieve these goals, the Parties commit to establish certain substantive offences in their laws which apply to computer crime. Although online identity theft is not *per se* mentioned in the Convention among the illegal activity that signatories must criminalise, it is indirectly covered under closely related crimes including illegal access to computers, illegally accessing computer data, and computer-related fraud that are listed in the Treaty.<sup>116</sup>

Parties to the Convention also agree to adopt domestic procedural laws to ensure that their law enforcement bodies have the necessary authority to deter, investigate and prosecute cybercrime offences and actively participate in international co-operation efforts. Such involvement should take the form of mutual assistance<sup>117</sup> for the purposes of investigations or proceedings concerning criminal offences related to computer systems and data, or for the real-time collection of traffic data that could evidence a criminal offence. Measures for the preservation of data are also set out. Moreover, the Convention invites its Parties to spontaneously share with each other information obtained within the framework of their own investigations when they consider that the disclosure of such information might assist another party in initiating or carrying out investigations or proceedings.<sup>118</sup>

As such, the Convention encourages a more coherent approach in the fight against cyber attacks. For example, it has been recognised as an important international benchmark for the development of cybercrime laws by APEC countries (APEC, 2006). Some companies in the private sector have taken some initiatives to help ensure a larger impact of the Convention's principles (Microsoft, 2006).<sup>119</sup> However, to date, the Convention has been mostly ratified by a majority of EU Member States and its ratification by many countries outside the EU is still needed to allow for a larger-scale implementation.<sup>120</sup>

- European Union ("EU") instruments
  - The EU e-communications regulatory framework

Several EU Directives set out measures to fight cyber attacks. Among them, Directive 95/46 on the Protection of Individuals with Regard to the Processing of Personal Data<sup>121</sup> lays out conditions for legitimate data processing (whether offline or online), one of which being that personal data may be only processed if the data subject has unambiguously given his consent.<sup>122</sup> The e-privacy Directive<sup>123</sup> reiterates this condition. Considering that users are very often not aware of the fact that outsiders can gain access to their computers and store information or programs with no means to control such illicit and hidden activity, Article 5.3 of the Directive states that "access to information stored in the terminal equipment of a subscriber or user is only allowed on condition that [he] is provided with clear information about the purposes of the processing and is offered the right to refuse such processing by the data controller." This provision does not only apply to so-called spyware<sup>124</sup> (hidden espionage programs) and Trojan horses (programs hidden in messages or in other innocent looking programs) but also to cookies (tracking devices which register users' preferences as they visit websites).<sup>125</sup> In addition, Article 13 of the Directive imposes a ban on spam.

Taking a significant step further, to improve co-operation between law enforcement, judicial authorities and the police in their fight against attacks on information systems, the EU Council, in its 2005/222/JHA Framework Decision,<sup>126</sup> called for an EU-wide approximation of criminal laws in this area. Considering that the measures adopted to date by EU Member States to introduce effective, proportionate and dissuasive sanctions to combat attacks against information systems were not sufficient, the Council, on the basis of the EC Treaty principle of subsidiarity,<sup>127</sup> imposed such a harmonisation on EU Member States. Under Article 2 of the Framework Decision, each EU Member State will have to take the necessary measures to ensure that the intentional access to the information system, illegal system and data interference are punishable as a criminal offence. Article 6 of the same decision further states that illegal system and data interference shall be punishable by criminal penalties of at least between one and three years of imprisonment. All these measures were to be adopted and implemented into EU Member States' legislation by 16 March 2007.

In November 2006 the European Commission adopted a Communication on *Fighting Spam, Spyware* and *Malicious Software*.<sup>128</sup> This Communication takes stock of the efforts made so far to fight these practices and concludes that there is currently insufficient action to address these threats to the Information Society. The Communication calls upon Member States to step up enforcement efforts using the already existing instruments and involve market players drawing on their expertise and available knowledge.

• EU-specific actions in relation to ID theft

Although no existing EU legislation specifically tackles ID theft, the EU has recently recognised the need for specific initiatives, proposing to consider it as an offence *per se*. The European Commission indeed sees the problem of ID theft as clearly growing, noting that the percentage of global credit card fraud which occurs in Europe grew from 12% in 2002 to 17% in 2003 (European Commission, 2004).

The European Commission's 2004-2007 Action Plan on the prevention of fraud on non-cash means of payment suggested examining *i*) the merits of establishing an EU single contact point for individuals against ID theft which could include a register of bodies engaged in the prevention of this illegal activity; *ii*) the creation of a database of original and counterfeit identity documents accessible to public authorities and the private sector. The Commission also reinforced the role of the EC Fraud Prevention Expert Group ("FPEG"), an independent body, chaired by the Commission, whose main objective is to intensify cooperation between interested parties, especially at the international level.<sup>129</sup> Various law enforcers, banks, retailers, consumer groups and network operators are members of the EU FPEG and exchange information and best practice to prevent fraud. In October 2007, its subgroup on ID theft issued a *Report on Identity Theft/Fraud* in the financial sector (EC FPEG, 2007), with a particular focus on payment and retail banking areas. The paper notably contains a number of recommendations for more tailored and consistent policy measures across the EU.

In parallel, the Commission's Directorate General for Justice, Freedom and Security ("DG FJS") organised in November 2006 a high level conference on the integrity of identities and payments to further strengthen public-private co-operation against identity theft and credit cards fraud.<sup>130</sup> In May 2007, the Commission adopted a Communication on a general policy on the fight against cybercrime announcing a series of actions including the launching of an in-depth analysis aimed at preparing a proposal for specific EU legislation against identity theft (EC, 2007, p. 10). On that basis, in July 2007, the Commission's DG FJS launched a comparative study on ID theft, examining the various definitions used in EU Member States and exploring the idea of criminalising the offence across the EU.

• The EU Regulation on Consumer Protection Co-operation ("CPC Regulation")<sup>131</sup>

Responding to the development of the Euro, e-commerce, and EU enlargement, the 2004 CPC Regulation calls on EU Member States to institute a minimum level of common investigation, enforcement, and co-operation powers among consumer protection enforcement bodies. The new Regulation, which entered into force on 1 January 2007 in all EU and EEA Member States, puts in place

mechanisms for effective enforcement co-operation against consumer fraud. It is notably aimed at tackling online scams.

Under Article 6.1 of the Regulation, a consumer protection agency shall, upon request from an applicant authority, "supply without delay any relevant information required to establish whether an intra-Community infringement has occurred or to establish there is a reasonable suspicion it may occur." It may also do so without request when it becomes aware of an infringement or where it suspects that such an infringement may occur. Under Article 8.1 of the Regulation, authorities in a Member State have the obligation, on request from their counterparts in other Member States, to take all necessary enforcement measures to bring about the cessation of an infringement without delay. The new framework thereby eliminates a situation where a public authority is prevented, under its national confidentiality rules, from communicating the necessary information requesting assistance from an authority in the member state of the trader. The Commission is creating a database through which consumer protection enforcement bodies will be able both to communicate with each other and to notify the existence of any unlawful intra-Community practices.

• EU agencies and bodies

Several agencies and bodies assist EU institutions in their fight against cyber crime. Among them, the following bodies are particularly active in the fight against identity theft:

- *Europol* provides expertise and technical support for investigations and operations related to cyber crime. In late October 2004, it participated in "Operation Firewall," an international sting to bring down a phishing operation. On that occasion, Europol co-ordinated efforts with the US Secret Service, the Department of Justice and Homeland Security Department, the Royal Canadian Mounted Police, the Vancouver Police Department's Financial Crimes Section, the UK National Hi-Tech Crimes Unit, and local police from Belarus, the Netherlands, Sweden and Ukraine to arrest 28 individuals from 8 states and 6 countries for using websites to steal identities, credit cards, and identity documents. This criminal organisation was successful in stealing one million credit card numbers and in creating fraudulent documents such as birth certificates.<sup>132</sup>

- The EU Contact Network of Spam Enforcement Authorities ("CNSA"): CNSA is a forum which facilitates the sharing of information and best practices in enforcing anti-spam laws between the national authorities of EU Member States and of the EEA. In February 2005, CNSA signed a voluntary agreement establishing a common procedure for handling cross-border complaints on spam. As mentioned above, in November 2006, CNSA and the LAP held a joint workshop on international enforcement co-operation against spam, spyware and other online threats. Speakers concluded that links with other international players fighting spam should be made to ensure enhanced international co-operation in the enforcement of anti-spam laws as well as education and awareness campaigns. In October 2007, the LAP will hold another joint meeting with CNSA that will also feature joint sessions with the MAAWG.

- The European Network and Information Security Agency ("ENISA"): ENISA is an EU agency funded by the European Commission. In 2006, it conducted a survey on measures taken by Internet service providers to safeguard the security of their services and fight against spam, spyware and other forms of malware (ENISA, 2006).

## Public-private sector international enforcement initiatives

The protection of the Internet infrastructure is a shared responsibility of business and government. Various international schemes where business joins public authorities' efforts to tackle cyber attacks come as a complement to government initiatives.

# Data Sharing Forums

• The Anti-Phishing Working Group ("APWG")

The APWG<sup>133</sup> defines itself as a global pan-industrial and law enforcement association focused on eliminating fraud and identity theft that result from phishing, pharming and e-mail spoofing of all types. It publishes monthly reports containing statistics on phishing aiming at measuring the scale of the threat.<sup>134</sup> It is largely co-ordinated via e-mail communications and meets periodically. On 30-31 May 2007, the APWG held the *Counter-eCrime Operations Summit*, which engaged "questions of operational challenges and the development of common resources for the first responders and forensic artisans who confront the e-crime threat."

### • DigitalPhishNet ("DPN")

DPN<sup>135</sup> is a collaborative forum where ISPs, online auction sites, financial institutions, and law enforcement agencies share statistics and best practice to tackle phishing and other online threats. DPN permits the sharing of information about phishers in real time to assist with identification, arrest, and prosecution.

• WHOIS

Law enforcement agencies and business<sup>136</sup> typically use WHOIS services, a public directory of domain name information. When a domain name is registered, the owner of the domain name's postal address, e-mail address and phone number are automatically published in WHOIS. WHOIS also enables access to data on Internet Protocol address allocations that can identify the physical locations where unlawful activity is taking place, and the relevant ISPs, which, in turn, can provide information regarding their customers. The Internet Corporation for Assigned Names and Numbers ("ICANN"), the non-profit body responsible for accrediting domain name registrars, requires that this personal information be accurate and available for anybody to view on the Internet.

## Consumer and Industry-led Enforcement Strategies

While laws can be slow to adapt to technological advances, in parallel to their participation in law enforcers' activities, businesses have developed their own enforcement strategies.

• The Trans Atlantic Consumer Dialogue ("TACD")

TACD is a forum where US and EU consumer organisations develop and agree joint consumer policy recommendations addressed to the US government and EU to promote consumers' interest in EU and US policy making. On 20 February 2007, TACD issued a *Resolution on ID theft, phishing and consumer*

*confidence*<sup>137</sup> recommending US and EU authorities to: adopt more specific laws prohibiting malware, spyware, ID theft and phishing; in particular, laws on ID theft should impose increased sanctions on fraudsters and should provide a duty for companies to disclose data security breach information to their customers. TACD also requests business to compensate victims for their financial and non-financial losses following ID theft (TACD, 2007).

• The Anti-Spyware Coalition ("ASC")

The ASC is a group composed of anti-spyware software companies, academics, and consumer groups. It focuses on the development of standard definition in relation to spyware. On 25 January 2007, the ASC published working documents on best practices<sup>138</sup> aimed at detailing the process by which anti-spyware companies identify software applications as spyware or other potentially unwanted technologies.

• The Messaging Anti-Abuse Working Group ("MAAWG")

MAAWG is an international organisation focused on preserving the electronic messaging from online exploits and abuse such as messaging spam, virus attacks, denial-of-service attacks, and other forms of abuse. These messaging service providers seek to enhance user trust and confidence.<sup>139</sup> On 15 May 2007, MAAWG issued the *MAAWG Sender Best Communications Practices* with collaborative input from both volume senders and Internet Service Providers. The *Best Practices guidelines* are a milestone toward industry agreement on how senders can distinguish their legitimate volume e-mail from unsolicited spam.<sup>140</sup>

• Private companies' actions (examples)

Some companies have implemented their own tools to combat cyber attacks. On 31 January 2007, Symantec launched its *Online Identity Initiative*, providing consumers with software enabling them to manage their identity safely while on line.<sup>141</sup>

Microsoft's *Anti-Virus Reward Program*<sup>142</sup> is another tool whereby the company will provide monetary rewards for information resulting in the arrest and conviction of parties launching malicious viruses and worms on line. In January 2006, the company provided investigative and technical support to Bulgarian authorities to help arrest eight members of an international criminal network whose phishing scam spoofing MSN's name invited consumers to reveal their personal information by "updating" their personal data such as credit card account details. The group had launched a co-ordinated attack on 43 servers located in 11 countries and defrauded US, German and UK credit card holders of more than USD 50 000.<sup>143</sup>

# **ISSUES FOR CONSIDERATION**

The analysis provided above suggests that stakeholders should consider addressing a number of issues to improve their efforts to combat online identity theft:

- *Definition* The lack of a common definition may complicate efforts to combat ID theft in a comprehensive fashion, across borders.
- *Legal status* ID theft/fraud is not an offence *per se* under most OECD member country laws. It is a crime in a few others. Whether ID theft should be treated as a stand-alone offence, and criminalised, needs to be considered.
- **Co-operation with private sector** The private sector should actively participate in the battle. member countries could consider enacting more restrictive laws increasing penalties imposed on ID thieves; engage in outreach to the private sector and encourage entities to *i*) launch awareness campaigns, *ii*) develop industry best practices and *iii*) develop and implement other technological solutions to reduce the incidence of ID theft.
- *Standards* member countries should examine establishing national standards for private sector data protection requirements and impose a duty to disclose data security breaches on companies and other organisations storing data about their customers.
- *Statistics* ID theft (whether off or on line) has failed to attract the attention of statisticians. Most data are from the United States; statistics for Europe do not exist, except for the United Kingdom. When data are available, they often do not cover ID theft as an independent wrong. The United States is notably one of the few countries with data available that analyse ID theft as a separate offense. The production of more tailored and accurate statistical data, covering all OECD member countries could help determine the impact of ID theft in the digital marketplace.
- *Victim assistance* member countries could consider developing victim assistance programmes to help victims of ID theft recover and minimise their injury.
- *Remedies* member countries could consider whether to enact legislation to provide more effective legal remedies for victims of ID theft.
- **Deterrence and enforcement** The lack of criminal laws prohibiting ID theft and the limited resources of law enforcement authorities may mean that there is insufficient deterrence. member countries could explore the value of increasing resources for law enforcement, ID theft investigations and training. More generally, given the rapid evolution of ID theft techniques and methods, more resources and training could be granted to all OECD authorities involved in the battle.
- *Education* Consideration could be given to broadening education on ID theft so as to cover all interested stakeholders including consumers, users, governments, businesses, and industry.
- **Co-ordination and co-operation** Agencies involved in the enforcement of anti-ID theft rules and practices are numerous at both domestic and international levels. Their respective roles and framework for co-operation could be clarified to help enhance their effectiveness. Consideration could be given to improving domestic law enforcement co-ordination by developing national centers dedicated to the investigation of ID theft crimes. With regard to co-ordination and co-operation with foreign law enforcement authorities, member countries could explore areas of mutual interest, such as *i*) enhancing deterrence, *ii*) expanding participation in key international instruments (*e.g.* the Council of Europe Convention on Cybercrime), *iii*) improving response to requests for investigative assistance, and *iv*) otherwise strengthening co-operation with foreign partners (*e.g.* in the fields of training law enforcement).

# **IV. Conclusions and recommendations**

## B. Further work on the gathering, analysis and dissemination of information

17. The available evidence clearly suggests that economic fraud is a serious problem, and is increasing, both globally and in a number of Member States. However, many States reported that they do not have accurate information or a systematic framework for gathering and analysing such information. [...] Data that would permit the quantification of fraud by occurrence or offence rates are not available in many States, almost no official data quantifying proceeds exists. [...] There is growing awareness of and concern about identity-related crime, but it represents a novel concept for law enforcement and criminal justice experts in many States. There are few legislative definitions and many basic concepts remain fluid at this early stage. [...]. The Intergovernmental expert group therefore made the following recommendations:

a. Further general research into economic fraud ... as a global issue should be conducted [...]

d. Systematic and structured processes for gathering and analysing data in each Member State are developed, and UNODC should be asked to assist in this process [...] Generally, such processes should include:

- (i) A standard typology or classification framework of offences or activities;
- (ii) The gathering of qualitative and quantitative information from multiple sources, including official offence reports or complaints and other sources [...].
- (iii) To the extent feasible, the gathering and analysis of information about the costs of fraud. This would include [...] the indirect economic costs, and the non-economic costs of fraud.

### D. Domestic powers to investigate, prosecute and punish fraud and identity-related crime

# 1. Legislative measures against fraud and identity-related crime

21. [...] While the vast majority of criminalisation issues appear to have been addressed, the evidence suggests that some specific enhancements could be considered to improve and modernise legislation. [...]

22. Lawmakers need to develop appropriate concepts, definitions and approaches to the criminalisation of a range of conduct, including identity theft, identity fraud, and other identity-related crimes. [...] It is therefore recommended that States consider the adoption of new identity-based criminal offences. It is also recommended that, in developing new offences, common approaches to criminalisation be taken, to the greatest extent possible. [...]

#### 4. Law enforcement and investigative capacity

27. [...]a. It is recommended that States develop and maintain adequate research capacity to keep abreast of new developments in the use of information, communication and commercial technologies in economic fraud and identity related crime.

b. It is also recommended that the product of research be shared and disseminated throughout law enforcement in each country in domestic training, and [...] with other States through appropriate technical assistance and training, and with relevant commercial entities.

d. It is further recommended that States support and make use of the "24/7" emergency contact network in transborder cybercrime matters, both for emergency and non-emergency cases involving electronic fraud or identity-related crimes.

# 5. Co-operation between criminal justice systems and the private sector

29. [...] [It is] essential that criminal justice and commercial entities co-operate effectively, both to develop an accurate [...] picture of the problems, and [...] to implement preventive and reactive measures.

30. To prevent fraud and identity related crime, it is important that security countermeasures be developed and incorporated into commercial technologies and practices when they are first developed. This requires consultation between public entities [...] and private interests [...]

32. A key element of prevention is the education and training of persons in a position to identify and report economic fraud [...], ranging from commercial customers or communication subscribers to employees [...]. Such training and education requires frequent updating, to ensure that information reflects the latest developments in criminal methods and techniques, law enforcement measures, and commercial practices. It is therefore recommended that criminal justice and commercial entities co-operate [...].

# 7. Recommendations for the prevention and deterrence of economic fraud and identity-related crime

[...] Close collaboration between relevant public and private sector entities in developing and implementing preventive measures will also be important for success [...]. It is therefore recommended that Member States develop and implement effective fraud-prevention measures, at the national, regional and global levels, and in co-operation with the private sector. Such prevention efforts could include the following.

- (a) The dissemination of information about fraud to potential victims [...].
- (b) The dissemination of information about fraud to others who may be in a position to identify, report and prevent frauds when they occur. Many commercial entities already train key employees in areas such as banking, credit card transactions [...].
- (c) The rapid and accurate gathering and analysis of information to support [...] prevention measures. This should include the gathering of information among law enforcement, commercial and other entities at the domestic level and [...] at the international level.
- (d) The rapid sharing of information among appropriate law-enforcement and private sector entities at both the domestic and international levels. [...].
- (e) The development of commercial practices and systems [...]. Effective collaboration between governments and the private sector are essential [...].

35. A number of responses mentioned a range of technical means of prevention [...]. These included measures to make documents such as passports or credit cards more reliable as a means of identifying individuals and more difficult to alter or falsify. [...] The establishment of stronger identification systems in every State would bring collective benefits for the international community in controlling crimes such as economic fraud, immigration or travel-related crimes such as trafficking in persons, and in general security.

(c). Government and commercial entities should co-operate to ensure that identification systems are robust and inter-operable to the extent that that is feasible.

36. [...] Further study and consideration of deterrence measures is therefore recommended. In addition to offences and punishments, this could include measures such as focused and specialised law enforcement units trained to deal with fraud cases, where these are seen as increasing the probability of detection, prosecution and punishment.

# 8. Training

37. One issue raised by some of the responses is the need for training investigators and prosecutors, and the need for technical assistance for developing countries in this area. [...] Those investigating identity-related crime require knowledge not only of crimes such as impersonation and forgery, but also knowledge of the identification infrastructures and systems which support both government and commercial forms of identification. [...]

# ANNEX II

# SURVEY OF TERMINOLOGY USED TO DESCRIBE "ID THEFT" IN OECD MEMBER COUNTRIES AS WELL AS IN INTERNATIONAL AND REGIONAL ORGANISATIONS

# "ID theft," "ID fraud," or "ID crime"?

OECD member country law enforcement authorities, industry, academics and the media use a variety of terminologies to characterise the problem. In some countries such as in the United States, Canada, or Korea, the concept of ID theft prevails. In contrast, other countries, mostly from the European Union, use the terms "identity fraud" or "identity crime" as synonyms. French-speaking countries refer to the terms ID theft ("vol d'identité") or impersonation ("usurpation d'identité") interchangeably.

According to Europol's 2006 EU Organised Crime Threat Assessment ("OCTA"), ID theft and ID fraud are subsets of ID crime. ID theft is itself a sub-category of ID fraud, as "identity fraud is broader than identity theft in that identity fraud refers to the fraudulent use of any identity, real or fictitious, while identity theft is limited to the theft of a real person's identity" (Europol, 2006, p. 18).

For the UN Intergovernmental Expert Group to prepare a study on Fraud and the Criminal Misuse and Falsification of Identity ("the UN IEG") (UN IEG, 2007), ID theft and fraud are also sub-categories of ID crime, which covers all forms of illicit conduct involving identity. It considers that cases in which identities or related information were simply fabricated are not analogous to either fraud or theft. The UN IEG distinguishes ID theft from ID fraud as follows:

- *ID theft* refers to occurrences in which information related to identity, which may include basic identification information and in some cases other personal information, is actually taken in some manner analogous to theft or fraud, including theft of tangible documents and intangible information, the taking of documents or information which are abandoned or freely available, and the deception of persons who have documents or information into surrendering them voluntarily.
- *Identity fraud* refers to the use of identification or identity information to commit other crimes or avoid detection and prosecution in some way.

According to the UN IEG, the element of deception, and hence the term "fraud," lies not in the use of deception to obtain the information, but *in the subsequent use of the information to deceive others*. As with economic fraud, this element of deception includes the deception of technical systems as well as human beings.

In the United Kingdom, ID theft has been defined (Home Office Identity Fraud Steering Committee, 2006) as "the act whereby someone obtains sufficient information about an identity to facilitate *identity fraud* ("ID fraud"), irrespective of whether, in the case of an individual, the victim is alive or dead." ID theft, whether on or off line, is therefore a preparatory step to commit subsequent fraud.

# ANNEX III

# MALWARE: DEFINITION OF TERMS

- *Backdoors*: A backdoor is a malicious program that allows an attacker to access a system by listening to commands on a certain User Diagram Protocol ("UDP") or Transmission Control Protocol (TCP) port. Backdoors facilitate the attacker's acquisition of information such as passwords and allows the attacker to execute remote commands.
- *Bots and botnets:* Some malware is distributed using botnets, a group of "zombies" or bots infected computers compromised though malware and turned into malware that can be used to carry out attacks against other computer systems. These computers become compromised when a bot program, a type of malware, is installed on the system.
- *Keystroke loggers*: A keystroke logger is a program that records and "logs" how a keyboard is used. There are two types of keystroke loggers. The first type of keystroke logger requires the attacker to retrieve the logged data from the compromised system. The second type of keystroke logger actively transmits the logged data.
- *Rootkit*: A rootkit is a set of programs designed to conceal the compromise of a computer at the most privileged base or 'root' level. As with most malware, rootkits require administrative access to run effectively, and once achieved can be virtually impossible to detect.
- *Spam*: There appears to be a growing correlation between malware and spam. Spam is commonly understood to mean unsolicited, unwanted and harmful electronic messages.
- *Spyware*: Spyware is a form of malware that sends information from a computer to a third party without the user's permission or knowledge. Different types of Spyware may collect different types of information. Some Spyware tracks the websites a user visits and then sends this information to an advertising agency while malicious variants attempt to intercept passwords or credit card numbers as a user enters them into a web form or other applications.
- *Trojan horses*: A Trojan horse is a computer program that appears legitimate but which actually has hidden functionality used to circumvent security measures and carry out attacks. Typically a Trojan enters a user's computer by exploiting a browser vulnerability or feature.
- *Virus*: A virus is a hidden software program that spreads by infecting another program and inserting a copy of itself into that program. A virus requires a host program to run before the virus can become active. The term "virus" is increasingly used more generically to refer to both viruses and worms.
- *Worm*: A worm is a type of malware that self replicates without the need for a host program. Worms can exploit weaknesses in a computer's operating system or other installed software and spread rapidly via the Internet. A mass-mailing worm is a worm that is spread out through bulk e-mail.

### ANNEX IV

# INITIATIVES AND STRATEGIES IN THE UNITED STATES

### Consumers' liability for unauthorized credit card charges

In testimony before the Ohio state legislature, the US FTC explained how the loss is allocated between individuals and businesses, stating that: [US] [federal law limits consumers' liability for unauthorized credit card charges to USD 50 per card as long as the credit card company is notified within 60 days of the unauthorized charge. See 12 C.F.R. § 226.12(b). Many credit card companies do not require consumers to pay the USD 50 and will not hold the consumers liable for unauthorized charges, no matter how much time has elapsed since the discovery of the loss or theft of the card. Consumers' liability for unauthorized debit card charges is limited to USD 50 in cases where the loss is reported within two business days, and to USD 500 if reported thereafter. See 15 U.S.C. § 1693g (a). In addition, if consumers do not report unauthorized use when they see it on their bank statement within 60 days of receiving the notice, they may be subject to unlimited liability for losses that occurred after that period. ID Public Entities, Personal Information, and Identity Theft, Hearing Before the Ohio Privacy and Public Records Access Study Comm. of the Ohio Senate and House of Representatives (2007) (prepared statement of the US FTC, delivered by Betsy Broder, Assistant Director of the Division of Privacy and Identity Protection).

## Public consumer and user education and awareness

The US DOJ has supported several different initiatives, such as the Ohio Identity Theft Verification Passport program (US IDTTF, 2007). The US Department of Treasury has also developed an ID theft resource page and serves as the head of the Financial Literacy and Education Commission, which is also comprised of 19 other US federal agencies and bureaus. This Commission launched a website and toll-free hotline for financial literacy in 2004, <u>www.MyMoney.gov</u>. The Department of Treasury and the Federal Reserve Banks also sponsor *Go Direct*, a campaign to motivate people who receive federal benefit checks to use direct deposit. Direct deposit helps eliminate the risk of stolen checks and reduces fraud.

### **Empowering domestic enforcement bodies**

#### Enhanced Domestic Co-ordination

The US Department of State's Bureau of Diplomatic Security is working on an initiative involving the prosecution of individuals who use the identities of deceased people to obtain US passports (US IDTTF, 2007, Vol. II., p. 52). In addition, the US Internal Revenue Service ("IRS") is targeting ID thieves involved in fraudulent tax refund schemes (US IDTTF, 2007, Vol. II., p. 51).

Other federal agencies in the United States have also increased their law enforcement efforts to fight ID theft. The US Secret Service is currently targeting suspects who are trafficking in governmentissued documents to reduce the online sale and distribution of stolen personal and financial information (US IDTTF, 2007, Vol. II., p. 51).

Special enforcement initiatives have been conducted to combat ID theft. For example, the FBI Cyber Division has conducted Operation "Retailers & Law Enforcement Against Fraud" ("RELEAF"), an international investigative initiative directed at reshipping — the use of one or more people to receive merchandise that criminals fraudulently purchased with others' credit cards to evade detection — and money laundering. This initiative, which involves more than 100 private sector participants and numerous law enforcement agencies, has resulted in more than 150 investigations.

The US Immigration and Customs Enforcement has established Document and Benefit Fraud Task Forces in 11 US cities to enhance interagency communications and improve federal, state, and local agencies' efforts to combat fraud that, by its nature, encompasses ID theft. Other federal agencies also actively participate in ID theft task forces, including the Social Security Administration, the IRS Criminal Investigation Division, and the Department of State's Bureau of Diplomatic Security (US IDTTF, 2007, Vol. II., p. 65-66).

The individual and co-ordinated efforts of federal law enforcement agencies in the United States have resulted in the prosecution of thousands of ID thieves. The US Sentencing Commission, which drafts criminal sentencing guidelines for federal offenses, maintains data that show that more than 1 000 offenders have been sentenced for convictions under the ID theft statute, 18 U.S.C. § 1028(a)(7), since its enactment in October 1998. The number of sentenced cases under the statute has increased substantially every year, from 12 cases in Fiscal Year 1999 to 195 cases in Fiscal Year 2006. Between Fiscal Years 1999 and 2006, the average sentences for these ID theft cases have increased steadily from an average of 16 months of confinement to 25 months of confinement (US IDTTF, 2007, Vol. II., p. 47).

In addition, the FBI reports that as of 30 September 2006, it had 1 274 pending ID theft-related cases, and that in Fiscal Year 2006, it opened 493 ID theft-related cases. In Fiscal Year 2006, the USPIS opened 1 269 ID theft cases and made 1,647 arrests, the US Secret Service made 3 402 ID theft arrests, and the US Social Security Administration reported that it opened 1 482 cases involving misuse of social security numbers (US IDTTF, 2007, Vol. II., p. 50).

To complement this scheme, the United States has developed data collection and sharing mechanisms to facilitate law enforcement prosecutions of ID theft. As mentioned in Section IV, the ID Theft Data Clearinghouse of the FTC logs ID theft complaints. The database is used by the FBI, USPIS, and other law enforcement officials for investigations (US IDTTF, 2007, Vol. II., p. 55). The Internet Crime Complaint Center ("IC3"), which was created by the FBI and the National White Collar Crime Center, is another conduit for complaints about Internet-related fraud and ID theft. IC3 offers law enforcement and regulatory agencies a central repository for complaints related to Internet crimes and allows them to retrieve timely statistical data and assess current crime trends.

In addition, the USPIS uses the Financial Crimes Database, a national database available to all postal inspectors, to analyse mail theft and ID theft complaints received from various sources, including the financial industry (American Express, Discover, MasterCard, Visa); major mailers (Netflix, Blockbuster, GameFly); the Identity Theft Assistance Center ("ITAC") complaints; online mail theft complaints, USPIS field offices; USPIS' telephone complaints; and US Treasury Checks (US IDTTF, 2007, Vol. II, p. 56).

### Data security breaches disclosure

In 2005, the US federal bank regulatory agencies also issued guidance for banks, savings associations, and credit unions relating to breach notification.<sup>144</sup> The guidance advises that the covered financial entities, as part of security programs implemented pursuant to the interagency security guidelines, should develop and implement a response program to respond to incidents of unauthorised access to or use of sensitive customer information. The response program must contain, among other things, procedures for notifying the primary federal regulator of the incident, notifying appropriate law enforcement authorities in

situations involving federal criminal violations requiring immediate attention, and notifying customers when warranted. The guidance also establishes standards for financial institutions to notify customers in the event of unauthorised access or misuse of sensitive customer information. If the institution becomes aware of an incident of unauthorised access to sensitive customer information, it should conduct a reasonable investigation to determine the likelihood that information has or will be misused. If the institution determines that misuse of customer information has occurred or is reasonably possible, it should notify any affected customer as soon as possible. The notice should be given in a clear and conspicuous manner, and it should include a description of the incident, the type of customer information affected, the steps taken to protect the customers' information from further unauthorized access, a telephone number that customers can call for further information and assistance, and other information relevant to the incident.

In addition to the US FTC data security enforcement actions, the US federal bank regulatory agencies have also initiated several enforcement actions against institutions failing to implement adequate programs to safeguard customer information. For instance, the FDIC had 17 formal enforcement actions between 2002 and 2006 (US IDTTF, 2007, Vol. II, p. 12). In the past five years, the Federal Reserve Board has taken 14 formal enforcement actions, the Office of the Comptroller of Currency has initiated 18 formal actions, and the Office of Thrift Supervision has taken 8 formal enforcement actions. In addition, these federal bank regulatory agencies have also taken several enforcement actions against financial institution insiders who breached their duty of trust to customers, were engaged in ID theft-related activities, or were otherwise involved in serious breaches or the misuse of customer information. These enforcement actions have resulted in bans from working in the financial services industry, personal cease and desist orders restricting the use of customer information, the assessment of significant civil money penalties, and orders requiring restitution.

## Private sector's role

Other US industry associations have offered guidance on improving information security. The National Association of Realtors has issued their own information security guidelines consolidating best practices of real estate agents, multiple listing services, and associations to improve their security safeguards (US IDTTF, 2007, Vol. II, p. 22). Major health care industry organisations such as the American Hospital Association and the American Medical Association produce informational materials such as handbooks and toolkits. In addition, these organisations partner with vendors to provide security and privacy guidance to their members and to enable compliance with HIPAA Security and Privacy Rules.
