Invites the chair of the CSTD to establish, in an open and inclusive manner, a working group, to seek, compile and review inputs from all UN member States and all other stakeholders on improvements to the IGF in line with its mandate as set out in the Tunis Agenda for the Information Society, and report to its next substantive session in 2011 with recommendations as appropriate. [to give recommendations for the improvement to the IGF without changing its basic features: multi-stakeholder character, not a decision taking forum]

WGIGF 4th meeting: drafting of recommendations

- Based on the topics (A to E) and on broad agreements
- Coherent texts with no ambiguity
- In case of dissent alternative recommendations in addition to recommendations by majority
- Interpretation should be straightforward (tasks, implementation, responsible body)
- Provisions for monitoring and evaluation

Conclusion

- Finalize text on 5th meeting 20-22 February 2012
- Recommendations as part or attachment to Chair's report to the 15th Session of CSTD May, 2012
- Draft resolution on WSIS follow-up to be approved by ECOSOC
- Resolution of ECOSOC to be endorsed by GA of UN at the end of 2012
- Monitoring of implementation
- Report on implementation of recommendations to 16th Session of CSTD May, 2013
