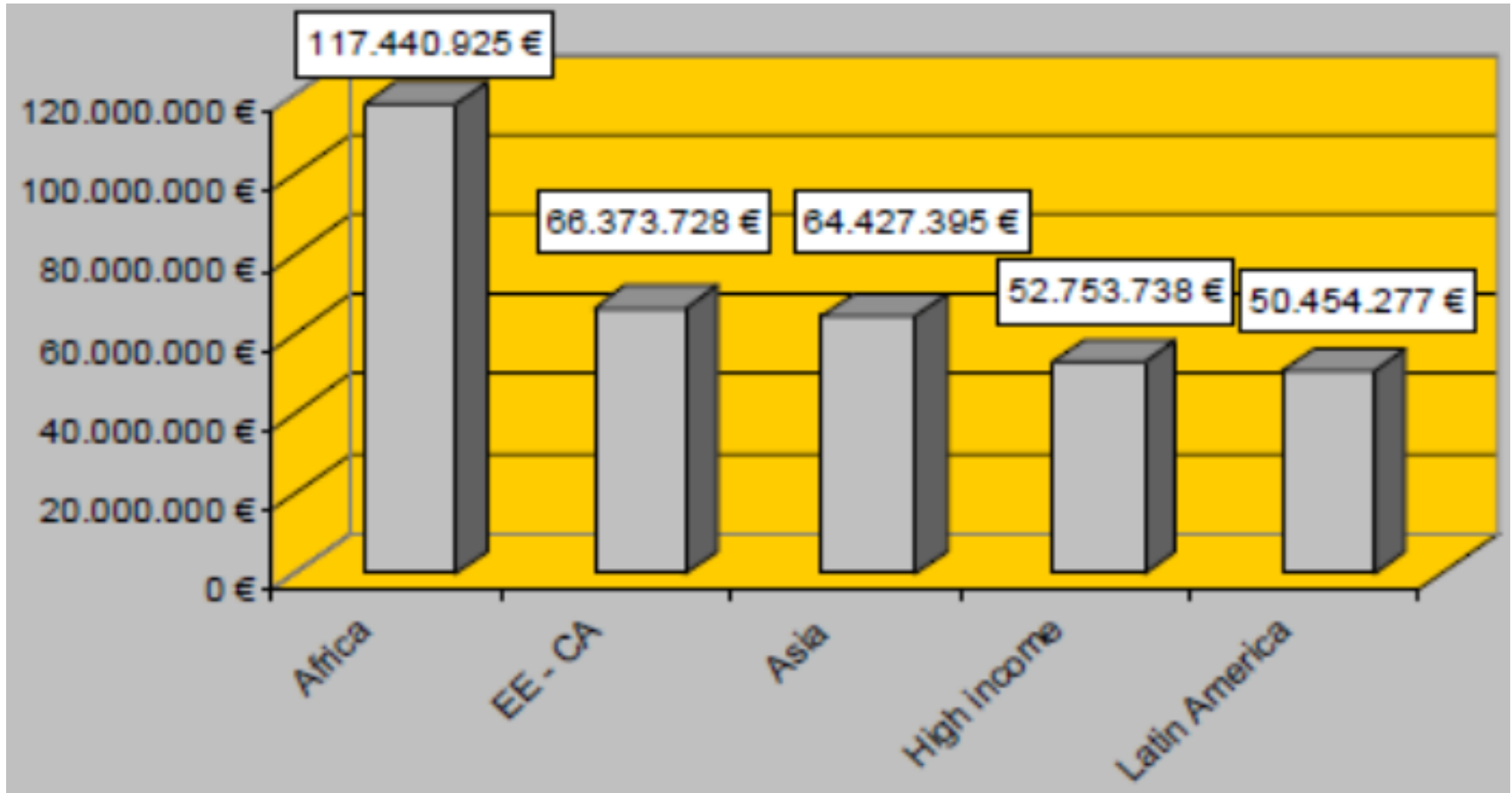

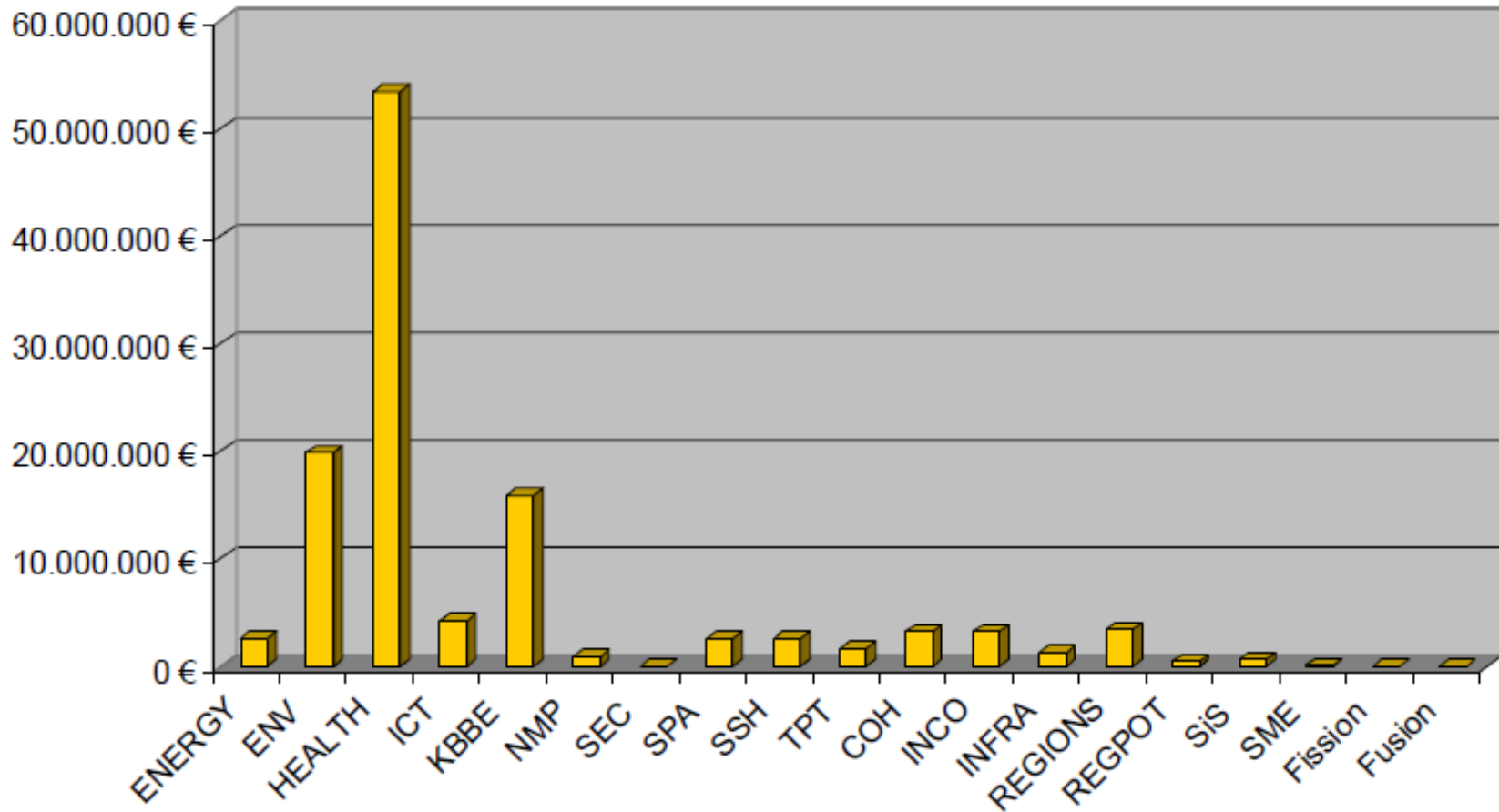
FP7 Contributions to Participants from External Countries – signed contracts per region

- Importance of S&T to the **knowledge based economy** and to the benefit of **Africa and Europe PEOPLE**
- Scientific cooperation is built on strong relationships of **TRUST** and **CONFIDENCE** for high quality **collaborative work**, and stands on the adoption of appropriate processes for their **sustainability**.

TRUST and **CONFIDENCE** ultimately depends on **PERSONAL relationships** between researchers, and on **Knowledge Networks** involving research institutions, universities and enterprises.

The **best possible framework** must be established for **BOTTOM UP** collaborations to flourish and to produce excellent research contributions to **SCIENCE, SOCIETY** and **ECONOMY**.

Priority Action 1: S&T capacity building for the implementation of Africa's S&T Consolidated Plan of Action (CPA)

Expected outcomes are the strengthening of:

- African S&T **capacities** and EU capacities for working with Africa
- **Training** of African and EU scientists, technicians and engineers
- **Exchange** programmes
- **S&T in REC's** sectoral programmes and projects
- Pan-African **infrastructure and facilities** for R&D
- AU-EU **High-Level S&T Policy Dialogue**
- S&T **cooperation** (bilateral, bi-regional, bi-continental, REC-level)
- **Innovation capability** of African and European SMEs
- **STI evidence-based AU-EU policy making**, including **Africa STI observatory**



EU-Africa 8th Partnership Action Plan II

Priority Action 1: S&T capacity building for the implementation of Africa's S&T Consolidated Plan of Action (CPA)

Thematic activities include:

- Support the AU objective of designing a **multi-annual African Research Framework**, *inter alia* by implementing the **African Research Grants Initiative**, as well as providing the AUC with the requisite experience and management capacity
- Complete the formulation of S&T for the development of **African SMEs and Business Incubators** network Lighthouse project
- Explore possibilities for Africa to support the deployment of **regional and global high quality research infrastructures**
- Set up an adequate mechanism to promote an **African brain-gain programme**
- Cooperate in **capacity building** in R&D and R&D policy in Africa and EU
- Focus on the **grand challenges** faced by Africa and Europe, e.g., **Climate Change / Energy, Sustainable Agriculture and National Resources Management, Desertification and Forestry, Water and Food Security, Global Health** (emphasis on Maternal and Child Health and Infectious Diseases)

Priority Action 2: Support the development of an inclusive Information Society in Africa

Expected outcomes are the strengthening of:

- **Inclusive** and **affordable access** and **use** of ICT applications and services in order to fast-track the MDGs objectives, notably in **health** and **education**
- Cooperation on the **digital economy** and the **reduction of the digital divide**
- African economy **competitiveness** through ICT uptake and innovation
- **Consultations on African-EU positions and approaches** in international and regional ICT *fora*
- **Mutually beneficial economic collaboration AU-EU** regarding ICT industries and SMEs



EU-Africa 8th Partnership Action Plan II

Priority Action 2: Support the development of an inclusive Information Society in Africa

Thematic activities include:

- Develop **Research and Education Networks (RENs)** interconnecting the European GEANT to African regional networks and progressing to a **pan-African REN**
- Set up an **AU-EU Information Society Dialogue** for ICT-related cooperation and to **coordinate EU and African positions in global ICT fora**, e.g. on digital literacy, inclusion, skills for RTD, regulatory issues, infrastructure deployment, use of e-applications
- Establish a **multi-stakeholders implementation group** to facilitate cooperation and better coordination of national and regional programmes, and to identify concrete initiatives of mutual interest, focused on:
 - **Harmonisation of ICT Policies** in Sub-Saharan Africa (HIPSSA)
 - **Sharing of ICT best practices and successful PPPs**, and improving the links of local/national/regional initiatives with international financing institutions active in ICT
 - Designing initiatives on **digital literacy, e-skills, local digital content, high socio-economic impact applications**
 - **ICT research cooperation, local ICT innovation and entrepreneurship**, promoting ICT **business incubators and Living Labs**

Priority Action 3: Enhance Cooperation on Space Applications and Technology

Expected outcomes are the strengthening of:

- **Pan-African Institutions** in space applications and technology
- **Integration of space-related issues** in specific dialogues and cooperation initiatives in areas such as **navigation, telecommunications and Earth observation for the environment and resource management, climate change, peace and security**
- **Specific projects based on existing space infrastructure (such as telemedicine)** to achieve **regional and global development goals**

Priority Action 3: Enhance Cooperation on Space Applications and Technology

Thematic activities include:

- Global Monitoring for Environment and Security (GMES) and Africa: Pursue the process initiated in 2007 at the Lisbon Summit, by **finalizing and implementing the Action Plan on GMES and Africa**, by developing the necessary **capacity building** efforts at continental, regional and national levels, by designing and implementing **appropriate coordination and governance mechanisms** aiming at a long-term cooperation
- Reformulate and support the implementation of the **African Geodetic Reference Frame (AFREF)** by providing an essential element for regional and multinational projects requiring precise positioning and geo-referencing
- Jointly establish a strong **African institutional and policy framework** for:
 - Promoting the exploitation of **space-based applications and technologies** in support of **development goals**
 - Assessing the feasibility of an **African Space Agency**, drawing on the expertise of the European and African Commissions, ESA, EUMETSAT and committed
