

Structure and working method of CSTD WG on Improvements to IGF

3rd meeting from 31 October to 2 November 2011

The objective of the CSTD Working Group is to give recommendations for the improvements of the IGF based on the recommendations/concrete suggestions received as responses to the questionnaire.

The work of the WG is based on the "Chairman's draft document".

The document is the list of recommendation/concrete suggestions for improvements derived from the summary of the recommendation prepared by Nermine el Saadany (Egypt) and Marília Maciel (Brazil). The recommendations are grouped into tables corresponding to the questions in the questionnaire.

In the tables:

Column 1 indicates the question number followed by the serial number of the recommendation. E.g. 4.1 identifies the first recommendation to question 4 "Shaping the outcome of IGF meetings"

Column 2 contains the recommendations

Column 3 refers to the status of the recommendation whether it is already implemented, partially implemented or not yet implemented. The status is to be evaluated by the members of the WG.

Column 4 is for comments to be given by the members of the WG.

Working method

Option 1: The document is discussed in Plenary with the participation of all members of the Working Group. List of recommendations is compiled based on consensus. In case of no consensus recommendation is either included in the list with the statement of divergent views or it is not included at all.

Option 2: In the first Plenary the WG proceeds to an overall preliminary review of the list with the objective to eliminate repetitions and those recommendations that have been already implemented. After finalizing the list the WG will be split into 3 sub-groups - Working Parties (WP). Each WP will work on responses to a group of questions and will report back to Plenary. WPs and Plenary will be held alternately. List of recommendations is compiled based on consensus. In case of no consensus recommendation is either included in the list with the statement of divergent views or it is not included at all.

- Q3: How to enhance the contribution of IGF to socio-economic development and towards Internationally Agreed Development Goals (IADGs) including enhancing participation of developing countries
- Q4: Shaping the outcome of IGF meetings
- Q5: Outreach to and cooperation with other organizations and forums dealing with IG issues
- Q6: Inclusiveness of the IGF process and of participation at the IGF meetings (in particular with regard to stakeholders from developing countries)
