A - Scientific Justification and work plan

This section should describe the background and the proposed research. The mode of cooperation between the Portuguese and Israeli groups, and the added value provided by the collaboration should be evident.

The project description should include:

- . Detailed description of the research topic including the state of the art in the research field and a discussion of the scientific and technological background of each element of the project.
- . Expected scientific, social and economic contribution of the project.
- . Detailed research program, including specific goals, methodology and work plan. Key scientific issues should be emphasized. The roles of Portugal and Israeli partners in carrying out the proposed research plan should be indicated, and the mode of integrating the work of the teams should be described.
- . Description of available research resources, including short CV's of research team members and inventory of relevant equipment.
- . Bibliography of relevant literature.
- . Letter of Agreement for the cooperation for all P.I.s
- . Please number the sections of the project description according to the numbers in the list above.
- . Items 1 through 3 are limited to a total of **8 pages**.
